Annual Report Fiscal Year ending 30 June 2014

This past Rotary year your Foundation was very active in project funding thanks to the successful fundraising efforts of the Club....you are to be commended. The Foundation endowment invested funds grew to \$291,310, an increase of \$33,066.94 (a 12.8% return) over the previous year. In addition, the Foundation has a yearend Current fund balance (checking account and money market fund) of \$41,044.00, of which \$22,289.28 is committed for checks written but not cleared plus approved project funding carried over into the new Rotary year.

During this past year the Foundation approved and funded 25 different projects (see attached exhibit A) for a total of \$86,942.83 in funding. Out of this amount, \$36,940 was pass-through designated funding for Stop Hunger Now, Shelter Box and the American Red Cross. The Club's other major projects approved and funded by the Foundation Board were High School Graduate Scholarships towards continuing college level education (\$10,000); Timber Lane Elementary School Reading Program (\$4,000); Partner for Surgery (\$5,000); and Michelo (\$5,168.91).
