1. WE FIGHT DISEASE AROUND THE WORLD. For decades, Rotary has been a leader in the battle against polio and has kept the pressure on as worldwide cases plummeted from 350,000 in 1988 to only 15 cases so far this year. We're closer than ever to ending this devastating disease.

2. WE TEACH PEOPLE TO READ. Our goal is to strengthen the capacity of communities to support basic education and literacy, reduce gender disparity in education, and increase adult literacy. We support education for all children and literacy for children and adults through mentoring, scholarships, teacher training, and access to learning opportunities.

3. WE BUILD PEACE. Rotary projects provide training that fosters understanding and provides communities with the skills to resolve conflicts. Our members are taking action to address the underlying causes of conflict, including poverty, inequality, ethnic tension, lack of access to education, and unequal distribution of resources.

4. WE PROVIDE CLEAN WATER, SANITION. Having clean water and sanitation is a human right. Rotary members integrate water, sanitation, and hygiene into education projects. When children learn about disease transmission and practice good hygiene, they miss less school. When people, especially children, have access to clean water, sanitation, and hygiene, they lead healthier and more successful lives. Rotary is helping to make clean water available to everyone by 2030.

**5.** WE GROW LOCAL ECONOMIES Nearly 800 million people live on less than \$1.90 a day. Rotary is working to strengthen local entrepreneurs and community leaders. We know that one solution doesn't fit every problem, so we work with people to help them help themselves.

6. WE SAVE MOTHERS AND CHILDREN. Rotary is saving lives by supplying birthing kits, immunizations, neonatal care equipment, and medical training. With access to quality care, mothers and children live longer and healthier lives, and Rotary is providing that care. GIVING TUESDAY IS NOVEMBER 29



# **Reflections on The Rotary Foundation** By Frank Raimy, TRF chair for the RC of Warrenton

I am honored to have been asked to share a few thoughts with you about my work with our Rotary Foundation. But first allow me to give you a little background.

I was invited into the Rotary Club of Warrenton in 1994. Since that time, I have had the pleasure of holding most offices including serving as the club president in 2000-2001. I

should also point out that we will celebrate 100 years of service in our community in 2026...so we are an established club.

But truth be told, our club for most of those years really did not support The Rotary Foundation (TRF) nor understood the significance of focused and sustained giving until around 1995 or so. One of our members had traveled internationally and discovered an area that desperately needed clean water for their community. He came back and made a presentation to our club and showed us a way to leverage The Rotary Foundation to make a meaningful difference in the lives of so many that we will never even know. That story resonated with our membership and helped us understand that we needed to consider doing more than occasionally passing the hat around the table for a needy family during the holidays. We helped establish two freshwater wells. That opened our eyes to the change that we as a small group could make to those less fortunate.

By 2009, many of us began to understand more about The Rotary Foundation, and the importance of our gifting. It was at that time that I accepted the position of club TRF chair. A good number of members became Paul Harris Society (PHS) members with five of us nearing Major Donor status. Our former TRF chair put it well when he said that "We drank the Kool-aide!"

At that time my goal was to encourage every member to become a Paul Harris Fellow (PHF)...and to my surprise, it happened! That year, as far as I can determine, was the first time we were recognized as a 100% PHF club. I learned about the use of points and how we could help folks participate. And every year up until last year my personal goal was to help our members either become a PHF or stretch to become a PHF+ participant.

After so many months of COVID lockdowns and lockouts our club started meeting in person again. At that time, we had 10 PHS members. Membership was picking up and people were excited to meet and breathe. I honestly believe that so many of us felt so very blessed to have come out of the restrictions on the healthy side that our hearts just made us want to do more.

By simply sharing the story of our TRF and the amazing works that it does, we added nineteen new PHS members! Honestly it was so easy. I simply asked folks to consider supporting our great financial arm of Rotary by sharing points along with their donation or becoming a PHS member right out of the blocks. And boy did my Rotary family respond!

To say that I felt humbled by the support of our members would be an understatement. But I think that for me, knowing that I have the great privilege to break bread every week with a family of people that has a heart for service and are truly making a difference in our world is why I drive sixty-five miles each way to my Thursday lunch meeting! I am truly blessed to be a member of a great group of people who each own a very special place in my heart.

If you are not currently supporting The Rotary Foundation, I encourage you to do so without delay. There is so much need right outside your door. # Rotary President Jennifer Jones announces US\$150 million pledge toward polio eradication

Rotary International President Jennifer Jones appeared on the main stage at the star-studded Global Citizen Festival on 24 September to highlight Rotary's commitment to eradicating polio and announce an additional US\$150 million pledge toward that end.

Jones, who spoke in front of 60,000 people in New York City and tens of thousands more online and on TV, noted the state of emergency that the governor of New York state recently declared to combat a resurgence of polio in the region.

In Pakistan, "frontline female health workers put themselves at risk every day," Jones said. "They are committed, even with obstacles, to reaching every last child with polio vaccines." The vaccination program works with the local police and government to ensure the safety of these health workers.

Jones talked about the effect of polio vaccinations in some countries being disrupted by COVID-19. She pointed out that in 2021, about 25 million children went without critical immunizations. "The world has beaten back this disease significantly, but we must redouble efforts," Jones said.

Rotary members have been at the center of the worldwide effort to eradicate polio for more than three decades. Rotary launched PolioPlus in 1985 and helped found the GPEI in 1988, when there were an estimated 350,000 polio cases across more than 125 countries in one year. Since then, cases have plummeted more than 99.9%, sparing more than 20 million people from paralysis. Rotary has helped immunize nearly 3 billion children against polio, contributed more than US\$2.6 billion to global polio eradication efforts, and helped secure more than US\$10 billion from donor governments.

Jones urged people to get involved: "Global citizens, use your voice — help us call on governments, businesses, and other leaders to join us in pledging ambitiously at the World Health Summit in October to end polio forever."



The Global Citizen Festival, an annual music celebration, urges world leaders to end extreme poverty, take action on climate change, empower girls and women, and dismantle systematic barriers. This year's Global Citizen Festival, which took place in New York City and in Accra, Ghana, called on global leaders to invest US\$600 million into the future of women and girls, narrow the US\$10 billion climate change shortfall, and provide US\$500 million to help farmers in Africa to respond to the global hunger crisis.. Rotary has worked with Global Citizen for a more than decade, primarily regarding the effort to eradicate polio worldwide


