PREVENTION OF DEAFNESS AND PROMOTION OF HEARING AMONG CHILDREN IN NEPAL

Twelve months ago, the Rotary Club of Kathmandu Mid-Town (KTM) invited me to speak at one of its Club meetings about the work of Ear Care Nepal (ECN), a charitable volunteer organization that I lead. The main purposes of ECN are to prevent hearing loss among economically disadvantaged school-age children in Nepal and to promote conservation of hearing through provision of ear care education, ear screening, primary ear care, and middle ear surgeries.



Ed Edmundson, a new member of the Potomac-Bethesda Rotary Club, listened to my speech. When he returned to Maryland, he advocated on behalf of ECN. Ultimately, PB Rotary obtained a matching grant from the District 7620 Foundation and was able to send \$3,700 to ECN through the KTM Club, which had agreed to administer these funds. Following the completion of over

children received middle surgeries to correct problems caused by middle ear infections sometimes known as chronic otitis media. If left untreated, these conditions can lead to eardrum perforations and destruction of little bones, thereby causing hearing loss and even death. After consultation with PB Rotary and KTM. \$400 remaining from the initial grant was released to pay for transportation to the Solukhumbhu District of Nepal for the purpose of ECN conducting "ear screening" camps. Solukhumbhu is located in a remote, mountainous district in Eastern Nepal that includes Mt. Everest. Salleri, its capital city, is about 150 miles from Kathmandu. Due to rough roads, it takes 10 to 12 hours to drive there. The ear screening camps were conducted at government schools and Buddhist monasteries, where school-age children are raised as young monks and nuns. The locations where the screening activities took place are accessible only on foot. Due to the very difficult terrain, the hard walk from Junbesi to Chheskam took four days. All of the screened children and their teachers received education on primary ear care via posters. power point presentations, and distribution of booklets that include drawings related to primary ear care. In Junbesi, ear screening



at two schools and two monasteries found that 7.68 percent of the public school children and 12.36 percent of the school-age children in the monasteries had middle ear pathology. In Chheskam, 9.88 percent of the screened children were similarly identified. Here are the overall statistics from the Junbesi and Chheskam ear screening camps:

· Number of children screened: 1,169. • Number identified as having middle ear problems causing various degrees of hearing loss: 120. • Number requiring ear surgery to restore their hearing: 15. • Number fitted with hearing aids: 8. I and ECN's other volunteer ear, nose, and throat surgeons will conduct all of the surgeries free of charge. ECN will incur various costs, including the cost of transporting the candidates for corrective surgery to and from the locations where their surgeries will be performed. Donations to ECN from various individuals and one Nepalese foundation, and discounts from anesthesiologists, a hospital, and a pharmacy will make all of this possible. The Solkhumbhu ear screening camps were a great success that will help in the prevention of deafness and promotion of hearing among many marginalized Nepalese children

ECN is very grateful to the PB Rotary Club for providing the \$3,700 grant, which was used very carefully in both surgical correction of deafness and in preventive care for many under-privileged Nepalese children.

2014-15 GLOBAL GRANT SCHOLAR UPDATE

I had been living and working as a volunteer in Nicaragua for two years when I found out about the Global Grant Scholarship to study peacerelated Masters abroad.



I had moved to Nicaragua to found a community organization educating youth in a rural Nicaragua. I worked long days and long weeks running afterschool programming, coordinating volunteers, fundraising, managing partnerships, and working to continuously dialogue with the community to adapt programs to fit their needs and goals. It was an incredible job, allowing me to live among an incredible community of families, live a simple life in a beautiful place, learn the language and culture, and discover what it meant to start and run a community project. While there were many benefits to the job, including living next to a beautiful crater lake, it did not come with a salary. I had been working to find a Nicaraguan for my position, and was ready to

move to a back seat supporting role in the organization.

While coordinating community projects, I became familiar with Rotary when I applied for and received a District Grant, I worked closely with host clubs, and a Rotarian in our sponsor club, upon hearing my goal of studying a Masters in Peace Studies, encouraged me to apply for a Global Grant. I applied with the support of the College Park Rotary Club in Maryland who sponsored me to compete within the District process. Almost a year later, I received news that I would be attending the University



for Peace in Costa Rica—as a Global Grant Scholar!

After three years living in rural Nicaragua, I felt like a Queen moving into my host family's house with a hot shower and clean drinking water from the tap!

Studying Gender and Peacebuiling at UPeace was like a dream. There were 150 students from all over the world who came to Costa Rica to study peace, focusing on human rights, international law, the environment, media, education, and gender. In the small school, there were over 60 languages spoken. and in my program of 13 students we represented 9 different countries from North and Central America, Africa, and Asia. The community of young, activist scholars passionate about peacebuilding was unlike anything I have ever experienced. I am hopeful to know they are working in their corners of the world brining their energy and expertise to transform local and global issues.

In September, I was hired as the Coordinator of Youth Projects at Earth Charter International based in Costa Rica. My job is engage and empower youth to build a more peaceful, just, and sustainable world. I hope to fulfill that mandate, and learn from impressive young people doing innovative, creative projects in their communities. One component of my work is partnering with other key organizations who are also working with a similar vision and I would love to explore the possibilities of partnering with the Rotaracts and exploring how the Earth Charter can be a useful tool in their development as positive leaders.

As I move forward with my career, I will remember and recognize the critical role that Rotary played in my education and career opportunities as a Global Grant Scholar. However, beyond remembering, I intend to continue engaging with this vibrant network of passionate peo-



ple and find ways to collaborate to achieve our collective dream of a more peaceful world.

US college, university or technical school for 2016-2017. Local Rotary Clubs will review their applicants and forward their finalist to the District Post-Secondary Scholarship Review Committee. Finalists will interviewed at the District level on April 9, 2016

Scholarship funds will be sent to the academic institution of winning scholars to cover tuition, room, board and books.

EMPHASIS ON PLANNED GIVING

IRA CHARITABLE ROLLOVER NOW PERMANENT, FROM ROTARY.ORG

Congress reinstated a law that allows you to make a tax-free gift from your individual retirement account (IRA). Known as the IRA charitable rollover, this law no longer has an expiration date so you are free to make annual gifts to The Rotary Foundation from your IRA this year and well into the future.

The recently reinstated law allows individuals 70½ and older the ability to transfer up to \$100,000 from their individual retirement accounts directly to a qualified charitable organization without being subject to income taxes on the distribution.

Here's the Details

You are age $70\frac{1}{2}$ or older at the time of the gift.

- You transfer up to \$100,000 directly from your IRA. This opportunity applies only to IRAs and not other types of retirement plans.
- You transfer the funds outright to one or more qualified charities. The legislation

does not permit direct transfers to charitable trusts, donor advised funds, charitable gift annuities or supporting organizations.

Frequently Asked Questions Q. I've already named The Rotary Foundation as the beneficiary of my IRA. What are the benefits if I make a gift now instead of after my lifetime?

A. By making a gift this year of up to \$100,000 from your IRA, you can see your philanthropic dollars at work. You are jump-starting the legacy you would like to leave and giving yourself the joy of watching your philanthropy take shape. Moreover, you can fulfill any outstanding pledge you may have already made by transferring that amount from your IRA under this legislation as long as it is \$100,000 or less for the year.

Q. I'm turning age 70½ in a few months. Can I make this gift now?

A. No. The legislation re-

quires you to reach age 70½ by the date you make the gift.

Q. I have several retirement accounts—some are pensions and some are IRAs. Does it matter which retirement account I use?

A. Yes. Direct rollovers to a qualified charity can only be made from an IRA. Under certain circumstances, however, you may be able to roll assets from a pension, profit sharing, 401(k) or 403(b) plan into an IRA and then make the transfer from the IRA directly to The Rotary Foundation. To determine if a rollover to an IRA is available for your plan, speak with your plan administrator.

Q. Can my gift be used as my minimum required distribution under the law?

A. Yes, absolutely. If you have not yet taken your required minimum distribution, the IRA charitable rollover gift can satisfy all or part of that requirement. Contact your IRA custodian to complete



How the Vehicle Donation Program works ...

- Rotarians generate vehicle donations through family, friends, and associates
- Melwood Charity Car Donation Center (District 7620's Partner) accepts cars, trucks, motorcycles, and RV's
 - As a rule there must be a clean vehicle title; towing is free to donor
- To donate simply call the Rotary 7620's toll-free number 1 844-686-7620, or go online to: http://goo.gl/dL3Pji
- Donor names Rotary Club to be credited for the donation
- Melwood's Call Center assigns the vehicle to a local towing and auction company
 - Donor provides vehicle title and keys to the tow truck operator; towing receipt left with the donor
- Once the vehicle has been picked up a receipt will be issued to the donor using District 7620 Trust Fund letterhead
- Vehicle sale information recorded and reported monthly to District 7620 Trust Fund; Club is advised by Trust Fund
- Upon sale, auction proceeds are forwarded to Melwood and management fees are deducted
- Residual forwarded to District 7620 Trust Fund for distribution to Club and/or beneficiary projects
- Melwood processes donor acknowledgement letter along with required IRS 1098C tax forms
- Melwood provides ongoing promotional support for District 7620 Trust Fund and participating Clubs
- Donation files are maintained by Melwood for a period of three years
