APPEAL

I am writing this appeal on behalf of the management of Sri Krishna Sevashrama Hospital Jayanagar Bengaluru India.

This charity hospital was established by Late H H Sri Vishvesha Thirtha Swamiji of Pejavara Mutt Udupi nearly 60 years ago. The aim was to provide affordable health care to the economically poor section of the society. What started as small clinic has now grown to 75 bedded Hospital with all major medical and surgical specialties. One of the areas where facilities are lacking is the specialty of ophthalmology. Though there is an outpatient department there is no dedicated operating suite available in the present location. The Consultants, after seeing the patients, are forced to refer patients who need to undergo a procedure like cataract to other centers nearby.

Considering this shortcoming, the management has decided to establish a specialized unit at the annex building no too far from the main hospital in Jayanagar, South Bengaluru. The entire second floor of the building is earmarked for this unit which will have outpatient consultation, and also a fully equipped operating theatre. There will be other facilities like waiting area, pre op and post op wards, consultant lounge, optical services etc The unit will have most modern equipment like operating microscope operating table, A Scan with patchy meter, and other surgical instruments.

As the hospital is charity in nature, all the funds have to come through donations, in order to keep the cost of the treatment at an affordable level.

In addition to the space and infrastructure and equipment there is a need for a dedicated team of experts including consultants, technicians and nurses all of which require large sum of money. A fund-raising initiative has started both here and in USA and it is hoped that there will be good response to this noble cause.

I sincerely thank Dr Pallavi Gowda who has come forward to help us reach organizations based in USA like Rotary Club of Potomac, Kaveri Kannada Association, Vokkaligara Parishat of USA and many other organizations and individuals through her gofund.me campaign. The donors will be kept informed of the flow of funds and its utilization in due course
