- Every Rotarian is expected to give a minimum of \$100 to The Rotary Foundation every year.
- Even if you have attained Paul Harris Fellow status, you are still expected to continue giving a minimum of \$100 to The Rotary Foundation every year.

Common Terms

Paul Harris Fellow (PHF) – An individual who contributes \$1000 to the Annual Fund or other approved programs

Multiple Paul Harris Fellow (PHF+) – A PHF will receive a new pin for each additional \$1000 contributed beyond their original PHF

Major Donor – Individual that has donated over \$10,000 to The Rotary Foundation

EREY (Every Rotarian Every Year) — Every member of a Club giving a donation to The Rotary Foundation with a minimum of \$25 and a club per cap of \$100

Sustaining Member – A member who gives \$100 very year to The Rotary Foundation

Benefactor – Individual that has made provisions for The Rotary Foundation to receive monies, after their death, thru the Endowment Fund.

Points – Members accumulate 1 point per each dollar. Points can be given to others to help achieve their first PHF or Multiple PHF
