## **Why should I donate to The Rotary Foundation?**

Your donation makes a difference to those who need our help most. More than 90 percent of donations go directly to supporting our service projects around the world.

## **How does The Rotary Foundation use donations?**

Our 35,000 clubs carry out sustainable service projects that support our six causes. With donations like yours, we've wiped out 99.9 percent of all polio cases. Your donation also trains future peacemakers, supports clean water, and strengthens local economies.

## **What impact can one donation have?**

It can save a life. A child can be protected from polio with as little as 60 cents. Our partners make your donation go even further. For every \$1 Rotary commits to polio eradication, the Bill & Melinda Gates Foundation has committed \$2.

- **Every Rotarian is expected to give a minimum of \$100 to The Rotary Foundation every year.**
- **Even if you have attained Paul Harris Fellow status, you are still expected to continue giving a minimum of \$100 to The Rotary Foundation every year.**

## **Common Terms**

Paul Harris Fellow (PHF) – An individual who contributes \$1000 to the Annual Fund or other approved programs

Multiple Paul Harris Fellow (PHF+) – A PHF will receive a new pin for each additional \$1000 contributed beyond their original PHF

Major Donor – Individual that has donated over \$10,000 to The Rotary Foundation

EREY (Every Rotarian Every Year) – Every member of a Club giving a donation to The Rotary Foundation with a minimum of \$25 and a club per cap of \$100

Sustaining Member – A member who gives \$100 very year to The Rotary Foundation

Benefactor – Individual that has made provisions for The Rotary Foundation to receive monies, after their death, thru the Endowment Fund.

Points – Members accumulate 1 point per each dollar. Points can be given to others to help achieve their first PHF or Multiple PHF

## TO SET UP YOUR ROTARY INTERNATIONAL SITE LOGIN

- Go to Rotary.org website
- Click on Myrotary.org
- Click on REGISTER in upper right hand corner of the page
- Put in your first name
- Put in your last name
- Put in your email address
- Click “yes” for over 18 yrs. or older
- An email will be sent to you within a minute or two to verify your new sign in information for the Rotary site. (If you don’t receive it within a few minutes, please check your junk or spam mail, or you can call 866-976-8279)
- Follow the directions on the email.

## TO SET UP YOUR PAYMENTS TO THE FOUNDATION THRU ‘ROTARY DIRECT’

- Go to Rotary.org website
- Click on “My Rotary”
- Log in
- Click on “GIVE” located just to the right of the search box.
- Click on the “DONATE” box
  - A screen will pop up with several options for giving.
- MOST IMPORTANT: Click on the first option “**Annual Fund – SHARE**”
- Hit CONTINUE
- Enter all your gift details. (Your annual total giving must be a minimum of \$100 per year.)
- Hit continue
- Complete billing information
