PLAN OF DISSOLUTION

Upon dissolution of the nonprofit corporation known as "Rotary Club of South Brunswick Islands, Inc." any liabilities and obligations of same will be paid and discharged by the President of the Corporation from funds of the organization's checking account.

All assets held by the corporation with condition to be returned or reconveyed upon dissolution shall be returned transferred, or conveyed in accordance with such requirements.

In addition, upon dissolution, all other assets shall be transferred or conveyed to Rotary International, a charitable organization under section 501(c)(3) of the Internal Revenue code of 1986.
