### Membership Options

#### Traditional Membership

Those who meet the requirements for membership, pay RI dues, are eligible to vote on club and district matters, are eligible to hold a club officer position and count in the club's membership numbers in Rotary's database.

#### Associate Membership

Associates are considered active members of Rotary similarly to traditional members. However, this membership **option is ONLY available to those new to Rotary (within their first year), and are less than 32 years old**. This option is only available for a member's first year of Rotary or until a member turns 32 (whichever comes first), and will transfer to a traditional membership after that point. This membership option provides a partial dues scholarship to qualified applicant that is approved by the Board. See breakdown below of the dues.

#### Family Membership

Family membership is open to family members (spouses, children, etc.) of a Rotarian similarly to traditional membership. The primary and secondary family members both pay dues to RI, the district, and the club. Meals will only be included in the primary's dues. If the secondary family member attends a meeting without the primary, they can use the primary's "meal ticket". If both are in attendance, the secondary would pay for the meal at the door. See the breakdown and comparison below between traditional membership and the family membership.

#### Optional Financial Expectation

It's expected that every Rotarian contributes \$100 per year to the Rotary International Foundation. It has been a policy that \$25/quarter is collected additionally to dues for this fund.
