<u>Policy</u>

Greenville Evening Rotary Charities will provide financial support within its means for selected Rotary International projects and for local individuals, families and organizations determined to be deserving of our support.

Rationale

To support the community service function of The Rotary Club of the Reedy River Greenville, the club engages in various fundraising activities from time to time.

Rotary International's causes are the following: Basic Education and Literacy; Disease Prevention and Management; Water, Sanitation, and Hygiene; Economic Empowerment and Community Development; Environmental Protection; Maternal and Child Health; Peace and Conflict Prevention.

Relevance to the Rotary causes is not required for grant consideration but is encouraged to be in alignment with these focuses.

Guidelines

To facilitate the distribution of net proceeds and the selection of recipients, it is important to have certain guidelines. They are as follows:

- 1) Net proceeds will not be disbursed to other organizations whose major focus is fundraising.
- 2) The Club desires to contribute a majority of its funds to organizations that serve a large number of people rather than one individual, one family, or a Capital campaign. However, each application for funding is evaluated on its own merits.
- Recipient must be able to provide evidence of benefits from donation of funds.
- 4) Recipient must give, and show evidence of, visible recognition to The Rotary Club of the Reedy River Greenville for the donation of funds.
- 5) Recipient is encouraged to include ways members of The Rotary Club of the Reedy River Greenville can also contribute time and service hours to the project, beyond the financial contributions.
- 6) If requested, the recipient must be able to provide receipts verifying the use of the granted funds.
