VENDOR BOOTH RULES

1. You must provide your own tents, tables, signage, etc.
2. Set-Up must be complete before 11:00 AM on the day of the Event. Arrival time is between 9-11 AM. Vehicles must clear and in parking area by 11:30AM
3. The area will be crowded with pedestrian (staff workers) traffic so please drive carefully. Vehicles may enter the festival area for loading and unloading only, but must be removed immediately when finished and must be parked 30 minutes prior to festival opening time at 12 noon. **Once you have entered these parking lots, you may NOT EXIT until festival closes for the day.**
4. Set-up Procedures – unload your vehicle at or as near to your space as you can get and then park your vehicle in the adjacent lot. Then return to your booth to set up. Please note: you may have to cart your items.
5. Do not sell items not listed on your applications without prior approval. You may only sell items that are listed on this form.
6. North Haven Rotary representatives have sole discretion on acceptability of items being sold and reserve the right to remove any items for sale that are not allowed.
7. Tables, tents, etc. are NOT to relocate or move from their assigned spaces. They must not infringe on other spaces
8. You are required to be on site all hours of the festival. Do not dismantle your booth, table, tent, etc until the festival closes. For Safety reasons, vehicles can not be allowed onto or off the festival area until pedestrian traffic has cleared, so you may not be cleared to move through the area when we immediately close. Security is on site during the festival; however, you are responsible for taking reasonable precautions to secure your area. The festival area is quite large and the security officers cannot be in all places at all times. Items are left in your area at your own risk.
9. Taste of New England is a Rain or Shine event and all vendors are expected to participate at all times.
10. The North Haven Rotary and the North Haven Fairgrounds are not responsible nor liable for damages, injury, or loss to any persons or goods from any cause whatsoever and cannot be held responsible for any claims for damages, injuries, or losses out of or in connection with the use of space or ground of the event.
