
President Sheila started the meeting at 1230

Irv introduced us to how DDF works. The Rotary Foundation gets our donations, and the district gets money back after 3 years. At 1302 in the zoom meeting recording, you can see Irv's talk. The international service committee facilitates the international student weekend, support to the orphanage in Nepal, and any international student exchanges. What Irv needs is people who can participate in selection process for international goals. Kathy asked about area clubs getting together for these projects? Irv said that's definitely on the list to be considered, because the minimum amount for an international project is 30,000 dollars. An example of a past multi club project was the work we helped with in Guatemala, as well as other projects. Paul Thompson asked about the possibility of helping the orphanage dig a deep well there. The cost is \$30,000 for the well.



Joel talked about pins (\$10) and badges (\$25). If a club member would like to buy a Rotary pin, they can be purchased at the check-in table. If you need a new badge because you classification has changed, or you'd like a badge with a magnetic fastener rather than a clip, let Joel Swanson know, and he'll get them ordered.
