# **Small Cog in a Big Wheel**

Find out how our club is following the example set by Rotary International.

It's that time of year again! We're asking you to nominate someone in the community to receive a Paul Harris Fellowship Award this spring. NOMINATIONS MUST BE RECEIVED BY MARCH 7<sup>TH</sup> 2024.

#### Paul Harris Fellowship Community Awards

**Overview:** Rotarians believe in the motto "Service Above Self". The best example of this is the work performed through The Rotary Foundation (TRF). Rotary established the Paul Harris Fellow recognition in 1957 to encourage and show appreciation for individuals who have made substantial contributions to The Rotary Foundation. The award is named in honor of the founder of Rotary. Paul Harris Fellows receive a certificate and pin.

Rotarians have a tradition of supporting the Foundation by honoring others. Since 1979, each Rotary club has been challenged to make at least one non-Rotarian a Paul Harris Fellow. The Rotary Club of Naperville has chosen to honor several non-Rotarians each year with Paul Harris Fellowships presented at a noon club meeting typically held in April or May.

Club members nominate non-Rotarians from our community who they feel are worthy of consideration for a Paul Harris Fellowship. The Foundation Committee reviews the nominees and selects the final recipients. The Foundation Committee also organizes the awards luncheon where a formal presentation is made to each recipient.

Nominations for the awards are organized under the "5 Avenues of Service" that guide Rotary Clubs worldwide. For the community awards, we extend the category definitions to include persons who contribute to other service clubs, non-profit organizations, educational institutions, and governmental agencies serving our community. All nominees must not be members of any Rotary Club. One or more awards are typically given each year in each category at the discretion of the Committee. Here are the five categories:

**Club Service** focuses on strengthening fellowship and ensuring the effective functioning of the club. Facilitation of training helps to strengthen member knowledge and skills. Clubs have serious topics to work toward, so having various social events that bring together members and their guests informally and for fun, contributes to genuine fellowship.

**Community Service** covers the projects and activities the club undertakes to improve life in its community. Nominees typically have contributed significant effort and leadership toward achievements by their organization that reflect the spirit and character of projects Rotary Clubs would undertake.

**International Service** encompasses actions taken to expand humanitarian reach around the globe and to promote world understanding and peace. Nominees have supported International Service by sponsoring one or more projects in another country, seeking international project partners to support projects in their own communities, or by personally volunteering at an international project site.

**Vocational Service** nominees serve others through their vocations and practice high ethical standards consistent with the expectations of Rotary Club members. They have significantly contributed to the betterment of the community using their professional skills.

**New Generations/Youth Service** nominees work to engage youths and young adults in leadership roles. This includes activities to promote leadership development in organizations similar to RYLA, Rotaract, and Interact, as well as promotion of service projects targeted for new generations/youth.

**Sample:** Mary Prekosovich is one of those people who could be described as an Energizer bunny, because she continues to keep going. More accurately, Mary continues to serve others than self, at the age of 96! She has been volunteering at Serendipity for over 20 years, which is a local resale shop selling clothes, jewelry, and other items for the benefit of the Little Friends organization providing services to those with developmental disabilities. Prior to giving birth to seven children, Mary was trained as a nurse; and as they grew she returned to school to reacquire her professional skills and then returned to work professionally. That included working at two nursing homes in Naperville, providing both physical and psychological services to seniors until she became 73. During and after employment, she served along with other volunteers in programs at DuPage County Jail, Grace Methodist Church, Hesed House, and St. Raphael's Catholic Church. She still continues in some of those programs plus at Serendipity. She is someone very special and well deserving of recognition as a Paul Harris Fellow.

## **Rear View Mirror**

This month club historian John Knobloch continues his Rotary Tour Around Naperville

After 54 years in Naperville, I have seen a lot of changes. With 28 years as a member of the Rotary Club of Naperville, there are many places in the city that bring back Rotary-related memories. Last month, we started our journey of the mind. Now, imagine that we are back on the road, to visit more of those sites:

Having said goodbye to Mike Briggs at the Naperville Country Club, we proceed west, into the older section of town. Going north on Loomis, as we approach North Central College, I am reminded of a meeting conducted by Gene Drendel (club president 1998-1999), with Rita Harvard (president 1994-1995), myself and possibly others at Gene's NCC office concerning the feasibility of the club employing a part-time administrator. Years later, this role would be filled by Erin O'Donnell.

North Central was also the stomping grounds of our former members Rick Spencer and Mike Squire, years before our current member Maria Caselli joined the club.

As we pass by Burlington Square Park, past president (1978-1979) Tom Eganhouse's former veterinary office is across the square. We also pause to admire "Spirit of the American Navy" and "Tragedy to Triumph," two pieces from the Century Walk Corporation. Brand Bobosky promoted the concept of such public art to the club in my early years as a member. The Century Walk board has included past club president Jim Bergeron, Sr. (1995-1996), Glen Ekey (1990-1991) and Rita Harvard (1994-1995), as well as Dick Galitz, Don Weber, Stephanie Penick, Joe Schultz, Mike Krol, John Higgins, Steve Coates, Chuck Seidel, Mindy Loebach, Jill Lejsek, and Roy Grundy.

As we cross the tracks on Loomis Street, the former Kroehler factory is on our left. Past president (1960-1961) Walt Schall was plant manager there for 21 years, until his retirement in 1979. After the building was redeveloped as Fifth Avenue Station, Raffi's on 5th, a restaurant owned and operated by our member Raffi Demerdjian, was a tenant there for twelve years. Raffi hosted a number of our members for one of our Business-to-Business lunches, on which occasion I was present there. (Other members were simultaneously hosted at the businesses of other members.)

Going east we pass the home of former Mayor George Pradel, a longtime member of the club and perhaps Naperville 's greatest cheerleader ever.

Turning north onto Columbia Street, we reach Ogden Ave. On the northwest corner of Ogden and Columbia once stood the Wheel-O-Meal drive-in restaurant, whose sign encouraged drivers something like "Don't drive by angry, stop in and get fed up." Aside from the wheel (Rotary wheel) connection (it's weak, I know), undoubtedly many Rotarians would have stopped there for lunch on occasion, on any day but Thursday.

We go west on Ogden and turn left to go south on Washington Street. On the left is the former office of Wehrli World Travel, owned and operated by Sue Wehrli, sergeant-at-arms during Brand Bobosky's year as president. Sue was quite the memorable foil to Brand throughout the year! If my memory is correct, Sue now splits her time between Door County and the U.S. Virgin Islands

Across the street is the longtime headquarters of the Bank of Naperville, later Harris Bank Naperville, then BMO Harris Bank, and now just BMO. Ward Stearns, club president for 1986-1987, served as president of the Bank of Naperville, and Frank Slocumb, club president for 2012-2013, was president of Harris Bank Naperville. Other Rotarians who have worked there (and sorry, but I am sure this is not a complete list) include Ron Davidson (who I would still really like to have back in the club), Chris Michalski, Lee Spadoni (now Przybyla), Jane Keith (now Stearns) and Pat Benton (RCON Downtown, the 4:44 Club).

Before heading South of the tracks, we stop at Kendall Park, at the southeast corner of Washington Street and Fifth Avenue to enjoy our lunch from Wheel O-Meal as we watch the trains go by. Once our batteries are recharged, we'll tour more of the Rotary-related sites south of the tracks.
