## Club Meeting - February 23, 2012

We sang "America the Beautiful" with Charlie Castner on the piano. We had no visiting Rotarians. Members recognized eight special guests. Marti Hazel introduced three Rotary birthday celebrants.

President Stet recognized three members who have recently been in the news. Next week is our 2012 Rotary Trade Expo, which will be in the Galt House East. The location for our meeting on March 8 is Walnut Street Baptist Church. Gary Noel reminded us that the Rotary Bowling Event is still scheduled for March 3 at Kingpin Lanes in Jeffersontown. One new member was introduced by Joyce Seymour. Carl Thomas became a Paul Harris Fellow.

President Stet turned the meeting over to Lelan Woodmansee to introduce our guest speaker, Mark Carter. He and his wife have three children and three grand-

children. Mr. Carter graduated from the University of Kentucky. He is a Certified Public Accountant. Mr. Carter spent 20 years in the health care practice of Ernst & Young.



Mr. Carter is the Chief Executive Officer for Passport Health Plan. Mr. Carter geared his presentation to increase our understanding of Passport and how Passport benefits the community. It has a mission of improving the quality of health and life of some of our most vulnerable community members. This Medicaid plan has 170,000 members, covers 16 counties in Kentucky, and employs 239 in the Louisville area. Passport is a not-for-profit public/private partnership which began 14 years ago. The Passport Health Plan is currently ranked #13 of all Medicaid plans in the country by the National Committee for Quality Assurance (NCQA). Passport is focusing on quality with the belief that cost gains will follow. Due to the well-publicized audit which took place a year ago, Passport has made dramatic changes. For every dollar spent, 94 cents is spent on medical care and only 6 cents covers administrative costs. The presentation ended after Mr. Carter took four questions from members. - Leo G. Smith
