

The 18th Annual Regional Speech Contest will be held on Thursday, and the winner will compete in the Rotary District 6710 Finals. The vitality, spirit and oratory abilities of these contestants expressed through the delivery of their speeches will be inspiring, challenging, as well as educational and entertaining.

This year's topic is the 2014-15 Rotary Theme, "Light Up Rotary," chosen by RI President Gary C.K. Huang. President Huang stated: "In Rotary we set our hearts right by putting Service Above Self. We recognize that in order to be ambitious in our service, we must first care for our own organization and expand our family of Rotary. In 2014-15, I will ask all Rotarians to Light Up Rotary—by sharing our service, strengthening our clubs, and letting our light shine in our communities."

The contestants are high school students from public and private schools, and each is sponsored by one or more Rotary Clubs in the area. Children of Rotarians are not eligible. Contestants speak without notes for a period of five to eight minutes, and will be judged on delivery, originality and content. The Speech Contest always generates enthusiasm, as the students are competing to attain cash prizes: 1st place—\$500; 2nd place—\$300. You won't want to miss this on the 16th!

For the first time in club history, on April 23 Rotary will host a Republican Gubernatorial Primary Panel Discussion. To provide ample time, the meeting will end at 1:30 pm.

## April 9, 2015 Rotary Meeting

The Rotary Club of Louisville meeting of April 9, 2015 was called to order by President Kevin Wardell. The invocation was provided by Dick Clay, who presented a Byzantine prayer from the 1400s. The Pledge of Allegiance was led by Gary Noel, who also led the Club's members in a recitation of the Rotary Four Way Test. Glenn Price introduced the Club's musical guests – UofL School of Music Associate Dean Naomi Oliphant (pianist) and baritone soloist Chad Sloan who sang a medley of songs from South Pacific. The performance was outstanding.

Various guests were introduced. Connie Cheak introduced the celebrants at the birthday table. President Kevin made a couple of announcements. On April 23<sup>rd</sup>, the Club will host for the first time a panel of four Republican candidates who are running to become Governor of Kentucky. Members are encouraged to submit their questions in advance, and the meeting will be extended to 1:30 PM. A few tickets remain for the Club's 50<sup>th</sup> Annual Day at the Downs. And, Stet Stetten encouraged all Club members to attend the annual fundraiser for the Club's foundation on May 12, during which several valuable items and incredible trips, etc., will be auctioned to the highest bidders.

Before President Kevin asked Lukas Dwelly to introduce our speaker, Kevin revealed his Duke University card (shown here) and shared a few humorous remarks about family members' basketball team rivals. Lukas Dwelly introduced Tom Jurich, UofL Vice President & Director of Athletics. Jurich has become one of the leading athletic directors in the United States and has held this position at UofL for 18 years. During his tenure, there has been significant improvement in the academic performance of student athletes. The UofL men's basketball program has been rated the nation's most valuable program from a financial

standpoint. Also, Tom reminded the audience of the university's key steps to build new athletics facilities all across the campus.

Of course, one of the most recent milestones has been joining the Atlantic Coast Conference (ACC). Since joining the ACC, the university has gone through a benchmarking process with other ACC schools in various categories, including academics. The goal is to be at or near the top in each category. Tom does not foresee any further expansion of the ACC beyond the current 15 members in the near future. During the question and answer session, Tom was asked his opinion on the issue of paying college athletes. Tom replied that, in his opinion, attending colleges as a student athlete is a privilege; however, if student athletes are to be paid, then all athletes in all sports should be paid. Tom commented further on reforms underway at the NCAA and what is being done to reduce/eliminate student violence and assault issues. - Respectfully submitted by Luke B. Schmidt
