Dan also served as the Executive Director for the Columbia Metropolitan Airport in West Columbia, SC; Eastern Iowa Airport in Cedar Rapids, IA; and Natrona County International Airport in Casper, WY. As a long-time leader in aviation organizations, Dan served on the Board of Examiners for the American Association of Airport Executives (AAAE), the Board of the Iowa Public Airports Association, was the state representative for the Great Lakes Chapter of AAAE, and is past President of both the Northwest Chapter of AAAE and the Wyoming Airport Operators Association.

## Mayor Greg Fischer - January 17th, 2019

Mayor Greg Fischer delivered a passionate State of the City address, notably on the birthday of Muhammad Ali, at the Ali Center, and a day after the announcement that Louisville's airport is to be re-named, Muhammad Ali International Airport. Stating that Ali's home town is persisting to be like him in pursuing its vision, he announced, "The State of the City is Strong," enumerating .... since the 2011 recession, we have added 80,000 new jobs, established 27,000 new businesses, welcomed \$13 billion in capital investments (including \$1 billion in West Louisville), and transformed our skyline with bridges and two dozen hotels that welcome more than 16 million visitors annually. Mayor Fischer pointed to our greatest need as fighting racism that still exists today, and to unite as a city to lift up our impoverished. "We can't lift up our neighborhoods without lifting up our neighbors", he said. The Mayor challenged Rotarians to join his Lean Into Louisville initiative to do just that. 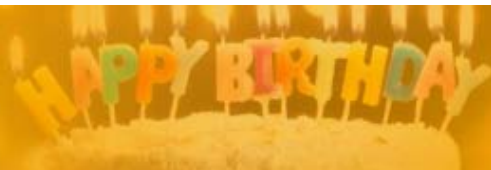

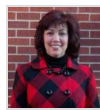
