Since taking office, Mayor Fischer has pursued three top goals: making Louisville a city of lifelong learning, a much healthier city and an even more compassionate community. These are the three pillars of his administration. As a businessman

and entrepreneur, he brings a data-driven approach to city government with a goal of making it more efficient and accessible.

Mayor Fischer is a trustee for the U.S. Conference of Mayors and is past chair of the Conference's Metro Economies Committee which addresses economic problems facing the nation's cities and their citizens. He was named a "Public Official of the Year" by Governing Magazine--the only U.S. mayor to earn that honor in 2013--and one of America's most interesting Mayors by Politico in 2017.




