## SERVICE PROJECT UPDATE

Our Service Projects Committee, and chair Ken Middleton, have been hard at work making sure the Rotary Club of Louisville is dedicated to "Service Above Self". As of today, the Rotary Fund of Louisville has approved 23 service projects (19 local, 4 international) with nearly \$100,000 in supported funds.

#### For 2016-17

19 are local projects: 17 are being funded entirely by our Club or the Rotary Fund. 1 project received additional funding of \$20,000 from an anonymous club member — 2 are receiving \$15,100 in supplemental funds from District 6710 as matching grants.

4 are international projects: 2 are sponsored by our club where we are requesting matching grants from the Rotary Foundation and support from other clubs — 2 are sponsored by other Rotary clubs to which we are are contributing.
