

Dr. Eli Capilouto became the 12th President of the University of Kentucky on July 1, 2011. Since his arrival, Dr. Capilouto has led a process to enrich UK's academic experience by investing in priorities that maintain affordability and access; support the institution's talented faculty and staff; and revitalize the living, learning and research facilities across campus.

Under Dr. Capilouto's leadership, the University of Kentucky – through an innovative public/private partnership – will add ten residential facilities across campus; nearly 4,600 beds and 175 active learning spaces by 2015. Additionally, the University is self-financing three capital projects essential to its academic and financial future: A renovated and expanded Gatton College of Business and Economics, a new Academic Science Building, and a renovated Commonwealth Stadium and Nutter Training Center.

Dr. Capilouto is committed to enhancing UK's research enterprise and graduate education programs through high-quality partner-ships, both domestic and international, and by recruiting and rewarding top scholars across the world.

A native of Montgomery, Alabama, Dr. Capilouto previously served as Provost of the University of Alabama-Birmingham (UAB) and Dean of the UAB School of Public Health. He holds several undergraduate and graduate degrees from schools within the University of Alabama system, and a Doctorate in Health Policy and Management from Harvard University. He and his wife, Dr. Mary Lynne Capilouto (D.M.D.) a former Dean of the UAB School of Dentistry, have one daughter.



Boss joined over 100 other participants in a fundraising event by climbing 39 flights of stairs. (Actually, it was no big deal for Bos since he climbs 31 flights EVERY day to get to his office.) President Randy also made special note of Rotarian Sam Swope's recent award – the Fluer de lis Leadership Award from the Louisville Forum in recognition of his significant contributions to the community throughout his career. The Foundation Football competition is over, with \$7,633.40 raised for the Rotary Foundation. There was a tie for first place between winners Jay Davidson and Jeff Underhill. James K. Murphy was honored as our newest Paul Harris Fellow, and Lukas Dwelly was awarded the "Service Above Self" award.

Rotarian Alice Bridges, Vice President at KentuckyOne Health, Rotary Board Member, Sustaining Rotary Member and Paul Harris Fellow introduced the guest speaker, Carol Gunderson, Director of the Food Literacy Project. Ms. Gunderson began her remarks by recognizing Rotary's support for the Food Literacy Projects efforts to build the "Food IQ" among area youth and create demand for fresh and healthy foods. The group's efforts have included an outdoor classroom for kids at Oxmoor Farm, where participants learn through participation as vegetables are raised and harvested. An extension of the groups work includes the Fresh Stop project, where families can pool money and SNAP benefits to purchase fresh produce directly from local farmers. Beginning in June, Rotarians will be able to purchase Fresh Stop shares for others. Approximately \$12 will provide a family of four with fresh produce for approximately two weeks. At present, efforts are focused on Wellington and Hazelwood Elementary Schools with the goal of promoting healthy food and lifestyles to prevent childhood obesity and disease. Following questions and the prize drawing, the meeting adjourned at 12:57.


