Greg Fischer was elected Louisville's 50th Mayor on November 2, 2010. Greg is an entrepreneur, businessman and philanthropist who started several businesses including SerVend International and Iceberg Ventures, a private investment. He also co-founded bCatalyst, the first business accelerator in Louisville. Past chairman of the Young Presidents Organization as well as past chairman of the Louisville Science Center, Greg helped raise \$25 million to modernize the facility. He co-founded Louisville's Center for Quality of Management and has served on numerous nonprofit boards with current roles on the University of Louisville Board of Overseers and the Waterfront Development Corp. Greg is a graduate of Trinity High School and majored in Economics at Vanderbilt University. He is married to Dr. Alexandra Gerassimides, and they have four children.

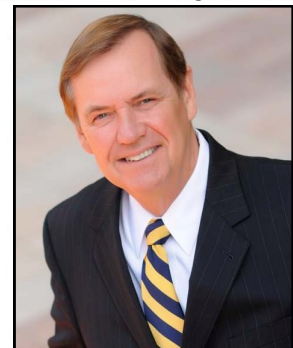

Chris Roberts, Rick Bell and

Introduced by Chris Roberts, writer and historian Rick Bell gave a 235-year perspective of Louisville in 20 minutes! Lots of very interesting facts and figures flowed. The Falls of the Ohio is the only natural impediment to navigation on the Ohio/Mississippi waterway in 2,000 miles. Louisville was the busiest river port in the U.S. in the 1850's with over 3,000 steamboat landings per year. Louisville's Portland Canal handles more tonnage than any other canal in the world. The most famous ferry service across the Ohio was Fontaine's ... a name many of us recognize and remember later in the amusement park, Fontaine Ferry Park.

One of the big issues facing Louisville in 1852 was where to build two new bridges. At that time, a big political debate was community merger, only between Louisville and Portland. Hmmm ... do these issues sound familiar?

Throughout the last two centuries plus, Louisville's riverfront has evolved to reflect the needs and desires of each generation. From an untamed river, to a bustling steamboat capital to heavy industry, to today's park and community meeting mecca, the river is the first impression of many of Louisville. Soon, we will all be enjoying perhaps the crowning glory to recent redevelopment efforts—conversion of the Big Four Bridge to a pedestrian walkway. - Don Cherrie
