### About Mayor Greg Fischer:

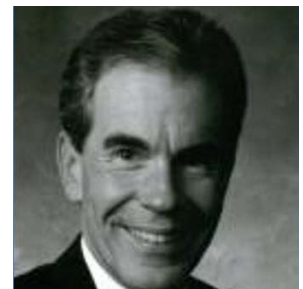
Greg Fischer was elected Louisville's 50th mayor in 2010 -- and was sworn in for a third four-year term on January 5, 2019. During Mayor Fischer's tenure, Louisville has experienced a renaissance, adding 83,000 jobs and 3,000 new businesses, with unprecedented investments in affordable housing. In addition, 20,000 Louisvillians have worked themselves out of poverty or into the middle class. More than \$15 billion dollars in capital construction is planned or underway, including 25 new hotels built to support the city's bourbon and local food tourism, also known as Bourbonism.

As President of the U.S. Conference of Mayors, Mayor Fischer is determined to work with America's mayors to set a bold agenda that promotes equity and opportunity for all as the nation's cities work to rebuild their economies in the wake of COVID-19 and renewed calls for racial justice.

The January 7th Rotary Club of Louisville Zoom meeting featured **Dr. Robert Fink**, System Director, Pharmacy Services, UofL Health and his presentation titled "COVID-19 Vaccine Information." Dr. Fink provided an update on UofL Health and his role in integration pharmacy operations within the system. He discussed the involvement with

Operation Warp Speed in bringing the first three COVID-19 treatments on-line and how this laid the foundation for COVID-19 vaccines. Dr. Fink also presented the nine leading COVID-19 vaccine candidates in the U.S., the Pfizer and Moderna vaccines specifically, and addressed certain FAQs.

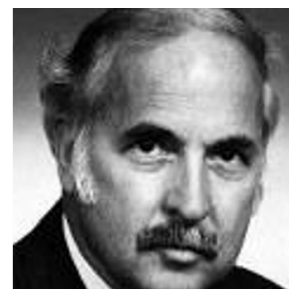

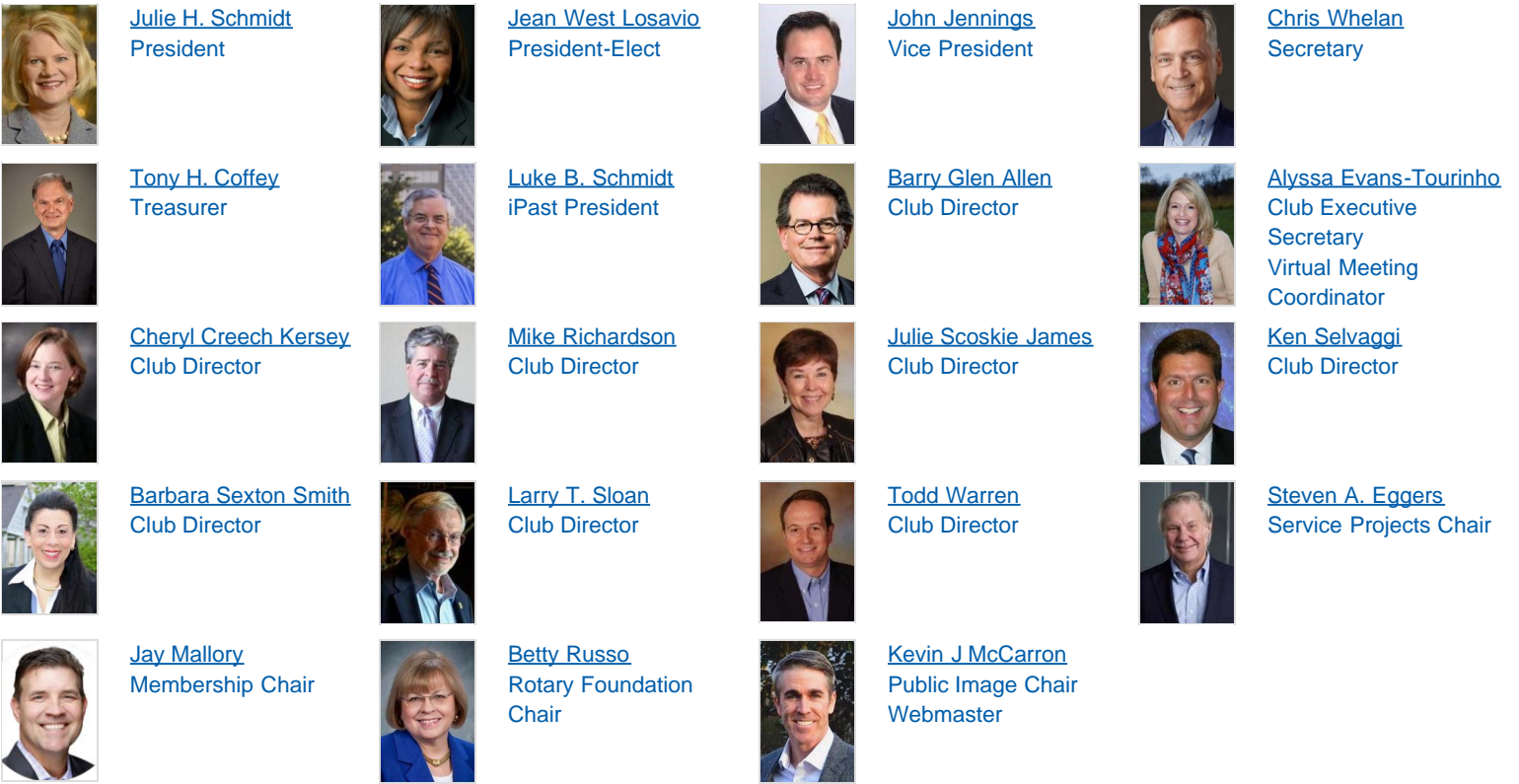
