# January 4th - Rotary Meeting Recap



Our January 4th Rotary Club meeting featured **Mayor Greg Fischer**. He delivered his annual "State of the City" address. The Mayor stated that the city is standing at a gateway to the future and took a look back at how the city fared in 2017. He listed statistics that indicated positive growth for the city such as 71,000 jobs and 2,500 new businesses being added since 2011 as well as 25 hotel projects currently being in progress. The Mayor then moved to challenges that Louisville is facing to include the burden the state pension issue may put on the city, the opiod crisis, and the outdated tax code.

Mayor Fischer also highlighted the way ahead by discussing some integral programs such as SummerWorks, the new JCPS Academies,

Manufacturing Training for English Language Learners (MTELL), Shelter Works, Project CASE and Code Louisville.

The Mayor also stressed the importance of being an equitable city for all. He stated an upcoming series of lectures, conversations, performances, and art exhibits that will help deepen the bonds between Louisville citizens. Mayor Fischer emphasized that the city must move forward, faster, together, and that inclusivity is also an important aspect as it relates to economic development.

The Mayor concluded the "State of the City" addess by stating that the future of Louisville demands new thinking. He called for universal pre-kindergarten so that every child has a chance to succeed. He featured a program that will provide a two-year community college education for all Jefferson County high schoolers - similar to the Rotary Promise Scholarship Program. He commended Rotarians on the efforts to provide opportunities for students to continue their education and promised some big announcements from funders later this year.
