James Dixon got involved in boxing in 1988, when he had the opportunity to work with some top-ranked boxers and match-make fights. He attended to family obligations for several years and built a successful construction business, but Dixon's passion and love for the sport led him to begin teaching his son Carlos the fundamentals of boxing from their garage in 2011. Encouraged by the positive changes Carlos was experiencing, Dixon began to train and support other local neighborhood kids and those in the surrounding area. His goal was to teach the kids discipline, respect, team work, hard work, and community service, effectively offering them an alternative path to that of drugs, gang life and trouble-making. Dixon's training sessions grew rapidly, and it was clear that his garage was inadequate for the scope of the great program he was building and the kids who were benefitting. JOINT meeting - Rotary and F&I invite Dennis Berman of the WSJ to speak!

Dennis K. Berman is Business Editor of The Wall Street Journal, overseeing the staff and coverage of business around the globe. He also writes a column, "The Game," which covers the future of business. Berman was previously deputy bureau chief for Money & Investing, helping oversee the Journal's financial coverage during the 2008-2009 financial crisis and rebuilding its presence on WSJ.com. Prior to that he was Global Deals Editor, responsible for leading the Journal's coverage of mergers, private equity, and bankruptcy.

For four years, Mr. Berman was the Journal's mergers and acquisitions reporter, breaking news on a series of large deals, including Bank of America's purchase of Merrill Lynch, AT&T's purchase of BellSouth, Sprint's purchase of Nextel, and Federated Department Stores' purchase of May Department Stores. In 2007, he launched Deal Journal on WSJ.com, now one of the site's most popular destinations.

He graduated magna cum laude from the University of Pennsylvania, is a media fellow at the Hoover Institution at Stanford University and is a Kentucky Colonel.
