Through many natural, financial and physical hardships facing her early agricultural pursuits, from drought to business failure and a severe horse-riding injury, Laura always had the persistence to keep working, and the insight to see market opportunities. After selling Laura's Lean Beef in 2007, she moved back to Kentucky in 2015 and began launching business after business from her Mt. Folly Farm, including several hemp-based products, a B&B, a mercantile store and Wildcat Willy's Distillery. In addition to the health benefits and expanding markets she is finding from hemp-based products, Laura also happily extols all the community and environmental benefits of buying local. 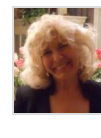

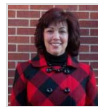
