

The Rev. Robert "Robin" T. Jennings has been an ordained Episcopal priest for nearly forty years. A graduate of Virginia Theological Seminary in 1974, he has served the Cathedral of St. Mary's in Memphis, Tennessee before coming to St. Francis in the Fields, Harrods Creek (Louisville) Kentucky, where he served as rector from 1983 -2014. His advanced studies include the Shalem program for Spiritual Direction and the Clergy Leadership Project sponsored by the Episcopal Church. In 2005 he was awarded the prestigious Lily Grant for sabbatical studies. He has recently been certified by Ministry Coaching International, and in 2011 was named one of the city's top religious leaders by Louisville Magazine.

In addition to church-related service, he has served on several civic boards in a volunteer capacity including the St. Francis School, The American Red Cross, Centre College, The University of the South, and he helped establish the Dare- to-Care food bank and the Kilgore Counseling Center. He is a member of the downtown Rotary Club of Louisville. He is the recipient of the Ben Kilgore Award and is author of numerous articles, biblical commentaries, and a collection of essays, Reflections from Harrods Creek and a new book entitled, May You Live in Christ: Spiritual Growth through the Vision of St. Peter. Mr. Jennings was awarded a BA from Centre College in Danville, Kentucky.

He is married to the former Mary McCutchan Moore and together they have four grown sons, and they have been blessed with two wonderful daughters-in- law and three lovely granddaughters. They reside in Louisville, Kentucky.

Visiting guests were welcomed and Rick King hosted the birthday table. President Kevin announced our next meeting is on Wednesday the 26th and will be held jointly with the Kiwanis Club. Thanks to Alice Bridges and those who volunteered at Oxmoor Farm for The Food Literacy Project. The leaders of the Foundation Football Fundraiser are Alice Bridges, Steve Eggers and Michael Shackelford. To date over \$2,900, has been raised. Matt Gardiner reminded us to get tickets for the Holiday Party that is on December 4th. November is Rotary Foundation Month. President Kevin asked all Paul Harris Fellows to stand. It was great to see so many standing, a true tribute to our club. The Newest Paul Harris Fellows, Maria Smith and Kristin Willard, were welcomed with a pin and certificate. Tony Coffey was given a new pin with an additional stone in recognition for making an additional \$1,000 donation. Also, Tony has joined the Paul Harris Society. Thank you to Maria, Kristen and Tony.

Presentation of the Board candidates for FY 2015-2016 was made by President Kevin and President-elect Greg Braun. Thanks to those who submitted their names for

nomination. If you were not selected, we will be looking to you for leadership in future committees and activities. The annual meeting will be at the December 11th luncheon and election results will be given at that time. For the first time, the election is online. Members will receive an email with a link to the voting website. You know the old expression, "one email one vote". Members will vote for four of the eight Director candidates. In no particular order, the candidates are Lukas Dwelly, Berry Barker, Thom Crimans, Rick King, Mary Michael Corbett, Mike Fallot, Muhammad Babar, and John Jennings. Candidates for the Treasurer position are Cyndi Caudill and Tom Bohnert. Candidates for the position of Secretary are Luke Schmidt and Karen Morrison. The candidates for the positions of 1st Vice President/President-Elect and Vice President are Ken Middleton, Alice Bridges and Dick Brien. The candidate receiving the most votes will be 1st Vice President/President-Elect and the other two will serve one-year terms as vice-presidents. All other positions are for two-year terms. Dennis Dolan introduced our speaker for the luncheon; Tony Zipple, CEO of Seven County Services. Tony has extensive training and teaching in the field of mental health. The seriously mentally ill, meaning those who are disabled by it, have ended up in our prison system, rather than in community supported treatment centers. The statistics are around 3% of all adults. Factors that contributed to this situation is the reduction in the number of mental hospitals, with the promise of community services, which never really materialized. Secondly, the surge of building lots of prisons and jails. However, jail doesn't cure mental illness. The rate of returning to jail multiple times is the result, and this is incredibly costly. The good news is that the ACT (Assertive Community Treatment) program, run by Seven County Services addresses the issue of working with the mental illness clients, over the age of 18. They start with the person in jail and a coordinated effort with the corrections department. The person will have a team from Seven County Services that provides comprehensive, integrated and intensive wrap around support. They work with the patient upon their release to meet basic living needs, counseling, medical treatment and medication. These individuals are historically non-compliant, poor and without family and have chronic medical needs. The team provides support to improve that, even if the client has "fired" them.

There are currently 90 participants in the ACT program. That requires ten staff members of professionals and paraprofessionals. In fact, team members include those who "have been there" and can bring their experience to the table. The program is used globally and has shown to significantly reduce the cost to care for these people who have traditionally been handled through the prison system and ERs. Some of the organizations that help coordinate the ACT support are Metro Corrections, LMPD, Jefferson County Court System, The Housing Authority, and the Kentucky Cabinet. The achievements of the program has been restoring lives, increasing public safety and saving tax dollars. The hope is to add two or more team after the next ten months. Tony wrapped up by saying that the program fits well with the goals of the 4-Way Test, especially the fourth guideline; will it be beneficial to all concerned. There was time for a few questions, after which President Kevin adjourned the meeting.


