David Ratterman is a graduate engineer and construction lawyer with Stites & Harbison. He has been a member of the Rotary Club of Louisville for nearly 30 years. David served as Secretary and General Counsel of the American Institute of Steel Construction for nearly 25 years. The AISC writes the engineering codes and standards used in steel-framed construction in the United States.

David provides a unique perspective on the evolution of the New York World Trade Center from its original construction in the 1960's, through its destruction in 2001, to its redesign and current reconstruction. He has represented construction industry clients involved in each of those phases of the World Trade Center's existence.

In 2002 David presented a program to Rotary based on the FEMA analysis of the mechanics of the collapse of the Twin Towers and some of the human agony and heroism involved in the cleanup effort. He's back now, ten years later, with firsthand photos and engineering data on the World Trade Center's reconstruction, and stories of the indomitable spirit of the New Yorkers who are rebuilding it.


