It's just not overseas, the threat of a terror attack may be right in our own backyard, and that has federal agents on high alert. The FBI says it has open investigations into possible terrorists and threats right here in Kentucky. With last month's terror attacks in Europe, the

Middle East and Africa top of mind, you will hear Thursday from Howard Marshall, Special Agent in Charge (SAC) of the FBI's Louisville Division, about terrorists in Kentucky and the agency's efforts to thwart it.

Director James B. Comey named Howard S. Marshall special agent in charge of the FBI's Louisville Division in July, 2014. Prior to that appointment, Mr. Marshall served as an inspector in the Inspection Division at FBI Headquarters in Washington, D.C. Mr. Marshall began his career as a special agent with the FBI in 1997. He was first assigned to the St. Louis Division, where he worked on a gang and fugitive task force. He then moved to a white-collar crime squad and conducted mortgage and bank fraud investigations. In 2003, he was promoted to supervisory special agent in the Cyber Division at FBI Headquarters. 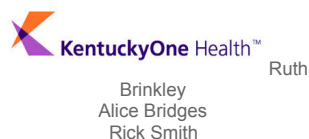
## Member Spotlight

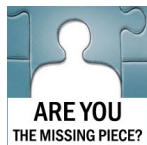
