Our guest speaker, Brig. Gen. Robert P. Givens, retired last month in September as Inspector General, Headquarters Air Combat Command, Joint Base Langley-Eustis, Va. He led more than 160 experts responsible for conducting more than 60 inspections annually. By spearheading both a rigorous inspection schedule and an open-complaint resolution process, General Givens ensures combat readiness, regulatory compliance, and complaint oversight for more than 225 active and gained units and more than 130,000 Airmen.

General Givens graduated from the U.S. Air Force Academy, and was commissioned in 1986. He has completed a variety of operational assignments in both the F-16 and A-10, is a graduate of the U.S. Air Force Fighter Weapons School and flew as the Right Wing for the USAF Thunderbirds.

He was a command pilot with more than 3,700 flying hours in the F-16 and A/O A-10. The general had more than 100 career combat sorties in operations Desert Storm, Southern Watch and Iraqi Freedom, and was twice decorated with the Distinguished Flying Cross for heroism in action in Iraq. His commands included the 35th Fighter Squadron, the 56th Operations Group and the 8th Fighter Wing.

General Givens' previous joint assignments include the Director of the Air Land Sea Application Center, Special Assistant to the Chairman, Joint Chiefs of Staff, Deputy Assistant Chief of Staff for Operations U.S. Forces Korea and Director, Combined Air and Space Operations Center, U.S. Air Forces Central Command, Southwest Asia.



October 3, 2013 Rotary Meeting

Well it was not our most favorite room, the Downtown Rotary Club assembled in the Daisy Sunflower Room with a certain sense of anticipation because the speaker, Todd Hollenbach, Kentucky State Treasurer, was promising to talk about unclaimed treasures currently held by the Commonwealth but belonging to Rotarians and others. The meeting began with an invocation offered by Dr. Muhummad Babar of the Jewish Physician Group. (Would It be Islamic or Jewish? In fact, it was directed to the singular Diety and was appropriate for all religions.) President Coe commemorated the life and achievements of Dr. Harold Kleinert, longtime member of the club and distinguished hand surgeon who had died during the previous week.

Several guests were introduced and the usual song was sung for the one Birthday celebrant present. Recent and forthcoming club events, social and athletic, were recognized, as was an impending "Membership Satisfaction Survey" which

all members of the club were urged to complete. The business part of the meeting ended with Glen Stuckel drawing our attention to the serious shortfall in funding for the Club's premier project, the Rotary Promise Scholarship.

President Coe then introduced our State Treasurer whose name was familiar to most members because it is the same as his father's who had preceded him in state and local politics. "I always enjoy speaking to Rotary", he began, and then described the process by which the Treasure Finders program had been able to restore to the family of Roy Owsley his medals and decorations after his death (Owsley, past president and member of the Louisville club, was a distinguished WWII veteran, who helped negotiate the ultimate surrender of Japan at the end of the war). These personal treasures were in a lockbox unknown to his family.

Hollenbach is particularly proud of the Treasure Finders program through which he hopes to return \$300 million to Kentuckians from the unclaimed assets, which are still held by the State Treasurer. \$93 million has already been paid out through this program. He urged everyone to check the website, www.missingmoney.com, a national database of unclaimed property. Currently, several states including Kentucky participate in the national database. Using the link on the Unclaimed Property main page, you can search the national database to determine if you or a loved one have unclaimed property in any of the member states.

Todd surprised everyone by reporting that his office had discovered unclaimed property owned by 68 Rotary Club of Louisville members ranging from \$5 to as much as \$19,000. He also announced that there was close to \$300 owned by the Rotary Club of Louisville. Rotarians lined up immediately after the meeting to see if their name was on the list.

As President Coe promised in July, the quarterly drawing was held from names of Rotarians with 60% or better attendance in the last three months, and the \$100 gift certificate to the RIVUE Restaurant at the Galt House went to Dan Hartlage! — David Reed


