



Looking through the Viewfinder:

The Life and Legacy of John Henry Harralson, Jr.

When you look through a camera's viewfinder you see the field of view. You frame and focus a picture to capture a memorable moment in history. Let's look through the camera viewfinder of one of the VOICE-TRIBUNE's anchors and sustainers for many years, John Henry Harralson, Jr. Through this viewfinder, we are reminded of how John captivated the minds of so many with stunning images and framing those in the social spotlight.

"He was a very social person," says Johnny, III (John's son). "He had a memory that was insane for people's names. He would go through his mental rolodex until he made every connection with people he knew with the same last name or related to people with the same last name... Dad was about people more than the art (of photography). There are some photographers who shoot for art, dad shot for people. Dad would always look for people who were interesting."

John was born in 1927 in Central City, Kentucky. His father John Harralson, Sr. was the town doctor, and his mother was the postmaster and librarian. He was raised in Central City and when he finished high school, he contemplated attending the University of Louisville (UofL) to complete his undergraduate education. John seemed to always have an interest in Louisville.

"When I was growing up, we would come to Louisville and stay at the Seelbach (Hotel). It was a very exciting time and a lot going on. We would go to the restaurants," John said in his downtown (Louisville) Rotary Club presentation back on July 27, 2000.

As he continued to decide his path after high school, he was told it would be better to go to the University of Kentucky (UK). At that time, UK's tuition was about \$60 a semester. UofL was a private school then and their tuition was higher than Harvard. A couple weeks later John went to UK and entered as a freshman in the late 1940s. He got a job working as the Kentucky Department of Highways Material Research Lab.

In his sophomore year of college, WWII broke out and his dad, John Harralson, Sr. (known as Jack), passed away. Although the fighting had ended, the war was still ongoing, and he was shipped to Japan and worked to rebuild the Misawa Air Base with the Army Core of Engineers. He then returned to UK and joined Phi Delta Theta Fraternity. He was a committed and devoted Wildcats fan. John finished his degree at UK in 1951.

John was also known for his humor and charisma. He had a contagious laugh and had a way of interacting and engaging others. There didn't seem to be a dull moment with him.

Life after college catapulted him to the newspaper business. John was offered roughly 11 jobs but decided to begin work at the Southern Bell Telephone Company because they wanted to put him in Louisville. He gained valuable experience through various executive positions with the telephone company, real estate, ad sales, and public relations. He retired in the late 1980s and had always had a nice camera collection.

During this time, he had a company called, National Growth and Investment which had other investors, and it had primarily been a company that bought and sold commercial real estate. He formed a subsidiary called, Southern Publishing and bought the Voice from the bankruptcy court. He later renamed the paper, The VOICE-TRIBUNE. As publisher and editor, John was an integral part to the VOICE-TRIBUNE's foundation for many years. His vision for the paper has evolved over the years but the original intent has been maintained.

"My mother had worked for the weekly paper in Central City, and I felt like there was a place for a small-town paper in Louisville, John continued to say in his Rotary presentation. "In 1987, with the help of John Chalek, we were able to buy The VOICE-TRIBUNE and resume publishing. Since we took over at the The VOICE-TRIBUNE, circulation has gone up over 800%. We now have over 60,000 readers and about 50% of the households in Jefferson County take a newspaper. Our survey shows that a lot of the younger readers don't take a daily paper and rely on the Voice and the television for their news."

The VOICE-TRIBUNE expanded its content and found its niche, covering a variety of topics and genres, from local news, sports, food, book reviews, and horoscopes.

"They built it from the ground up," says Johnny, "and dad took the unofficial position as the staff photographer. Dad liked going to events. He liked taking pictures, but he would also go to business openings and things like that. It became very popular. People like to see themselves in the paper. It was social media before there was social media. Back then, that was what you did for a selfie. You would get dad to take your picture and hopefully it would land in the Voice, in the next issue. He really got into it and had a good time with the paper. He became an icon of the Louisville social scene."

Combining John's affinity for people and communication skills along with his love for photography made it a "natural fit" for him to be a newspaper man. For those who only knew John as a legendary photographer, his family remembers keen characteristics about him. As a man who worked a lot, he exhibited commitment and diligence in his craft. Johnny recalls many times when his dad would stay up all night, shoot pictures, and be in the window of the Voice office during the middle of the night. John loved to work and was a "steady force" in his family. He was never too high and never too low, setting an example for his children. He did not get angry much and thought critically to solve issues and problems.

He was also a man who developed strength and fortitude. After losing his father during his college years, he had to find a way to finish college. His resolution was to go into the Army and then finish school on the GI Bill. In addition to finishing college through his resilience and persistence, John also remained steady during the changes and transitions at the Southern Bell Telephone Company. Being able to weather the storm as an employee provided an intangible strength and stability in the home.

Why Harlan County by Gill Holland

Geoff Marietta, Jacki Bentley and I are so thrilled with the opening this past November of the Harlan County Beer Company. Some folks here in Louisville have wondered and asked me "Why Harlan?" There are oh-so many reasons! As a country, we need to break down the urban-rural divide and as a state we need to diversify the economy of the coal towns that built this country. Kentucky needs to catch up with the Appalachian states around us which have already leveraged great tourism opportunities with the mountainous temperate rain forest that is Appalachia. Tennessee has Gatlinburg and Blackberry Farm, West Virginia has the over 200 year-old Greenbrier Resort, North Carolina has Asheville, and so on. Harlan County is in an amazing rebuilding and re-imagining phase. Harlan has history, the rarely found authenticity people crave in this crazy world, and unparalleled natural beauty.

First, my father was born in Harlan County, in Lynch, the famous coal town created in 1917 by US Steel to help the United States get more energy to build more military materiel to win World War I. Lynch had at one point 10,000 people, bustling with a movie theater, and the hospital where my grandfather was a doctor. Now there are about 600 people living there. My great grandfather moved in with his son and died in Harlan in 1937. So on one level it's personal.

But secondly, Harlan County is arguably the most famous county in America. In the 1930's when my family was there, the Harlan County War, commonly referred to as Bloody Harlan, took place. The series of fights, strikes, skirmishes, etc between the coal companies and law enforcement (including federal troops coming in multiple times, and Kentucky's National Guard) and the miners and labor unions led to untold deaths and significant national press coverage. Activists around the country, poets like John Dos Passos, became involved, and the haunting song which Pete Seeger made famous in 1941 "Which Side Are You On" was written by Florence Reece whose husband Sam was one of the strike organizers.

Which side are you on boys?
Which side are you on?
They say in Harlan County
There are no neutrals there.
You'll either be a union man
Or a thug for J. H. Blair.

And of course there's Darrell Scott's classic "You'll Never Leave Harlan Alive" covered by everyone from Brad Paisley to Patty Loveless to Chris Stapleton (at the AMA country Music Awards last year).


