

January 27, 2022 Meeting - Dr. Uric Dufrene - Louisville Metro Economic Update & Outlook



How will the Louisville economy fare over 2022? Will payroll gains accelerate, or can we expect an overall slowdown? The presentation will examine the economic outlook for Louisville Metro, including headwinds and tailwinds facing the economy. What is the state of the consumer in 2022, and key Louisville industries like manufacturing, leisure and hospitality and transportation and warehousing. Early in the pandemic, Professor Dufrene was calling for a V-shape recovery followed by moderate growth. Professor Dufrene will present a view of the national economy, along with key indicators for Louisville Metro, and an update to the early projection of the V-shape recovery.

<u>Dr. Uric Dufrene</u> holds the Sanders Chair in Business at IU Southeast. As the Sanders Chair in Business, he gives the annual outlook for Southern Indiana and Greater Louisville at the annual Economic Outlook Breakfast and Mid-Year Outlook programs. Professor Dufrene also speaks to various community groups and organizations across Southern Indiana and provides ongoing updates through economic update columns. He obtained his BS and MBA from Nicholls State University in Thibodaux, Louisiana and his Ph.D. from the University of Mississippi. Professor Dufrene began his career as an Assistant Professor of Finance in the School of Business, served as Dean of the School of Business, and Executive Vice Chancellor for Academic Affairs. He teaches corporate finance in the School of Business at IU Southeast and has been following the regional economy for almost 20 years.

February 3, 2022 Meeting - Ron Schmidt - Kentucky in the Catbird Seat: This Field Looks Green To Me



Our featured speaker will be Ron Schmidt, presenting "Kentucky in the Catbird Seat: This Field Looks Green To Me"

This is a story of eight men who defied Jim Crow \diamondsuit it \diamondsuit s a story of leadership and relationships. Four of the men fought at the Battle of the Bulge and upon returning from Europe made a decision that sent ripples through society. Having witnessed evilness in the world, they came home to laws made by men that had weakened their community; laws that forbade kids to play together. These men \diamondsuit crossed the color-line \diamondsuit by forming the first integrated Little League program in Kentucky \diamondsuit the second in the South. The kids they coached, black and white, followed the lead of their mentors and learned to trust each other and play like a team, despite outside pressures to keep them apart. Their leadership and mentoring caught a community by surprise, just as their league shocked the entire state.

February 10, 2022 Meeting - Mayor Fischer's Final State of the City Address

Greg Fischer was elected Louisville s 50th mayor in 2010 -- and was sworn in for a third four-year term on January 5, 2019.

Governing Magazine named Mayor Fischer Public Official of the Year in 2013. A 2016 Politico survey named him as the most innovative mayor in America, and in 2017, Politico named Mayor Fischer among its list of the nation s most interesting mayors. America s mayors elected him to serve as president of the U.S. Conference of Mayors in July 2020.

Mayor Fischer is a national award-winning entrepreneur who started and invested in dozens of businesses, including SerVend International and Iceberg Ventures, a private investment firm. He also co-founded bCatalyst, the first business accelerator in Louisville.



Mayor Fischer is a graduate of Trinity High School and Vanderbilt University. He is married to Dr. Alexandra Gerassimides, the daughter of Greek immigrants who were uprooted during the Greek Civil War. The couple have four adult children and one granddaughter.



Rotarians in the Spotlight

Look who was on the big screen at the U of L Women's Basketball game on Sunday! Rotarian **Joyce Seymour** was recognized for all that she has done for girls basketball in Kentucky. For over 53 years, she played or officiated. In 1973, soon after Title IX passed, Joyce and longtime friend, Bunny Daugherty founded what is now the Republic Bank Girls Louisville Invitational Tournament. They used their own money to buy basketballs, print programs and pay officials.

Joyce is a UK graduate that lettered in basketball and three other sports. During her UK basketball career, she averaged 19 points and 11 rebounds, and her team was undefeated for all four years. She was UK s MVP three of the four years she



played basketball. During the 1960s and 70s she traveled extensively throughout the state offering clinics for girls, coaches and officials at both the high school and college

levels. Joyce s vision of what girls basketball could become has resulted in over 600 teams and 8,000 girls playing in the Girls Louisville Invitational Tournament. Congratulations Joyce!
