The former CEO of Gray Construction, one of the nation's leading designers and builders of large-scale manufacturing facilities, Gray has brought a businessman's approach to city government by creating strong financial and operational management systems; and by making strategic investments in planning and development initiatives. Mayor Gray has received national attention for his partnership with Louisville Mayor Greg Fischer. The Bluegrass Economic Advancement Movement (BEAM) is a partnership between Louisville, Lexington and the Brookings Institution with a mission to create a world-class advanced manufacturing and technology super-region in Central Kentucky.

Since taking office in January 2011, Gray addressed an immediate short-term budget deficit of \$9 million; as well as the next year's \$27 million deficit, an amount equal to 10% of the City's General Fund Budget. Gray has led the charge to

build an arts and cultural district centered on a reinvented Rupp Arena, home of the NCAA champion University of Kentucky Wildcats, on 46 acres of city-owned land in the center of Lexington's historic and vibrant downtown. Gray is a graduate of Vanderbilt University and in 1996 was appointed a Loeb Fellow at Harvard University.

Rotary Meeting - April 12, 2012

Our meeting was held in the Galt House West. Rev. Robin Jennings gave the invocation. Barbara Collins led us in the Pledge. She also introduced our soloist, Daniel Weeks, accompanied by pianist, Naomi Oliphant, both UofL faculty members. President Stet introduced two visiting Rotarians. Michael Vincenti hosted our birthday table of three celebrants. Wayne Perkey made a request for us to submit "Rotarian of the Year" nominations by May 3. President Stet thanked the Club volunteers who assisted in the WFPL phone drive. He also reminded us that the 47th Annual Rotary Day at the Downs is May 1. President Stet introduced Kathy Evitts as our newest Paul Harris Fellow. Lexington Rotary Club Member, Rob McGoodwin, and President Stet each bestowed an Honorary Club membership and badge to our guest speaker, Dr. Jim Ramsey, President of the University of Louisville.

President Stet then turned the meeting over to Henry Heuser, Jr., who introduced Dr. Ramsey. Dr. Ramsey provided information about three milestones in the history of UofL. First,

the university was formed in 1798 by a group of forward-thinking benefactors who believed that Louisville needed a university in order to build a successful community. Second, in 1970 the university became a public institution. Lastly, in 1997 the Kentucky General Assembly set forth its charge that UofL should transform itself into a "Premier Nationally Recognized Metropolitan Research University."

Dr. Ramsey stated that a lot has happened at the university since 1997. The amount of research funding has increased substantially. The university is attracting better and brighter students, including 68 high school valedictorians who are in its entering class. UofL has 14 Fulbright Scholars. The university's list of accomplishments in the medical field is growing steadily. The university is reaching out to gifted students who need financial assistance. The School of Dentistry is taking dental care to rural areas of Kentucky. There are more students living on campus in wonderful new housing facilities. And the list goes on.

Dr. Ramsey is particularly dismayed that U of L has received 13 budget cuts in the last 12 years, with a 6.4% budget cut looming on the horizon. He stated that it is a sad commentary on our society that education is being cut at a time when it is needed the most. Of particular concern to Dr. Ramsey is the fact that only 24% of the Kentucky population has a college degree. He translates that into the reason why the average per capita income in Kentucky is only 80% of the national average.
