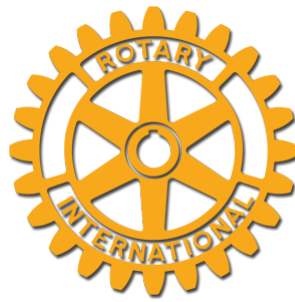

Clemens is a graduate of Raymond High School and holds a bachelor's degree from Washington State University. She is currently enrolled in the University of South Dakota's Executive Master of Public Administration program.
