Joel Napp (by Paula Laschober)

Joel Napp has been a Rotarian for about 60 years, and has been a member of our club for 18 years. His prior clubs include Carmichael, Hayward, Concord and West Sacramento, California. He was a member of these clubs because the bank he worked for, Crocker Bank (later acquired by Wells Fargo), moved him to the different locations. However, it's important to note that Joel did not join Rotary because it was his bank's policy. He joined

because he knew other Rotarians as bank customers and liked the "status" of being one of them. His sponsor was the manager of a JC Penney store. The club met at that time in a dilapidated WWII Quonset hut. (Continued on page 3)

When the food was cooked, the families would come into the dining area to select what they would like to eat and meet the volunteers.

Now that Covid is over, Rick and his wife, Pat, want to catch up on traveling. And he hopes to see us soon.

Tom said that his involvement with Rotary as a newbie in Seattle was "kind of like heaven" as the environment at the UDRC was exactly what he was used to experiencing. That is, he was used to interacting with business owners and professionals. He found the weekly lunches to be an opportunity to learn more about Seattle as well as find options for volunteering. He believes that the UDRC continues that tradition today.

In 2010, Tom left People's (but not UDRC) to begin a commercial lending consulting business. Until he retired a few years ago, he worked with family-owned businesses

looking to sell or to expand significantly. His retirement occurred over an eighteen-month period when he was completing current projects bur decided not to take on any new clients.

During his time in Rotary, Tom served on both the Service Fund Board and the Club Board in addition to other service projects and committees. He was and is particularly interested in helping young people having both tutoring experience with UDRC and from his years as a Big Brother in the past.

With only positive memories from being a Rotarian, Tom would be happy to be remembered as a Good Rotarian. He believes that the 4 Way Test is as an honorable way to live life as there is – that is, with no regrets. He also stated that he was singularly blessed by his choice of parents. In fact, he asked his father to be the Best Man at his wedding instead of another of his male friends. He said that his father was the best man that he knew.

Tom also feels that his being a parent has been most rewarding. He has two children (son & daughter) and three grandchildren (2 girls and 1 boy). His daughter and her family live outside of Chicago while his son's family is in the Seattle area. Tom couldn't be prouder of his son who shared the following about his father:

Rain or shine, he always showed up for Tom Jr.'s baseball and soccer games;

He generously donated his time to church and volunteer organizations;

He helped his son to understand the value of philanthropy.

As a result of his father's example, Tom Jr now volunteers extensively for men's groups, schools, and he coaches soccer and basketball as well.

Of course, just to prove that his father is human after all, his son also noted: during his childhood when coming home from church one week, his father took a wrong step and fell into their pool in his Sunday's best suit. Despite that small misstep, Tom Andrew was and is known as dependable and honorable.

Tom will be honored as an Honorary Member of the UDRC on June 28th though his active membership will not end until November this year.

Joel was President of the Carmichael Rotary Club in 1976-77. Prior to taking office, he joined Toastmasters so he'd feel comfortable talking to large groups. He said this was before the existence of PETS training, and incoming Presidents were left to their own devices. Later, he was co-treasurer of another California club; he says he took the money and the other member, a CPA, filed the tax return. During his tenure with UDRC, Joel was a member of the Program Committee for about 10 years. Of that experience, he says: "It was fun because you really found out what was happening in the club."

Some of Joel's fondest Rotary memories are from meeting makeups. He remembers several European cruises where he did makeups on ships. He also made up a meeting in Rome, a block from the US Embassy, where the speaker discussed the Internet. At a makeup in Bordeaux, France, Joel himself was tapped as speaker; he said he couldn't do it because he couldn't speak French, but the local German Consul General offered to translate for him, so Joel was able to tell the Bordeaux club about his California club. Joel also made up once in Tel Aviv.

At a makeup in London, Joel noted that they ended the meeting with excuses for why some members would not attend future meetings. A makeup meeting for his Hayward Club was done as a "fly in"; members had to arrive in an airplane and Joel remembers a very bumpy ride. He also attended meetings in the Caribbean as makeups. This situation occurred because his wife, Aline, was President of Inner Wheel, and that organization had meetings there, which he attended with her. Joel and Aline noted that Inner Wheel was an organization founded in London after WWII, for wives of Rotarians. It continues today as a service organization for women.

Joel notes several differences between Rotary when he first became a member and today. For one thing, there used to be a "senior-active" classification. Likewise, many clubs used to "fine" members for non-attendance at meetings. And, he says, you used to have to complete a makeup within one week, whereas now you get two. Of course, women could not be Rotarians when Joel joined. He remembers when his own club discussed whether they would admit women. The majority voted "yes," but some members said they would leave the club if that happened. Ultimately, no one left.

Rotary used to sponsor group study exchanges, and Joel and Aline hosted several beneficiaries of that program in their California home. They hosted an Australian girl who play basketball with the boys and whose mother told her she "was losing her Australian accent." They also hosted two Russian landscape architects, and a doctor and pharmacist from Chile.

Joel and Aline are Paul Harris Fellows and Joel holds the title of "Benefactor" of The Rotary Foundation (TRF)

—which means he has included the TRF Endowment Fund as a beneficiary of his estate. They have attended three international conventions--at Chicago, San Francisco, and Portland--and many District conventions.

Joel says he wants to be remembered for his friendship, and what he'll miss most in Rotary is the fellowship. He also notes that one of his best memories of activities at our club was staffing our booth at the U District Street Fair.

Joel and Aline have two sons, Jeffrey and Kevin. Jeffrey, who was a speaker at one of our club meetings, is an oceanographer with NOAA, and Kevin is a helicopter paramedic. The Napps also have one granddaughter. Several family members will be joining Joel and Aline at our June 28 meeting.

UDRC Rotarians Make Lunches at U District Family Y (by Rick Jones)


This past Sunday the 16th was the 3rd Sunday in the month of June.


