### Sam Frigo Inducted August 23 as New Rotarian (by Rosemary Aragon)

Today we are inducting Sam Frigo.

He got to know his sponsor Ling Chinn through TKElevator, where he is her Account Manager and helped her with a modernization at one of her properties in the International District.

Sam was born and raised in St. Louis, Missouri. His senior year he graduated from River Falls, Wisconsin. His Mom and dad still in live in St Louis. His older brother resides in Fisco, Texas.

Sam attended Augsburg University in 2007-08. Augsburg University is a private university in Minneapolis, Minnesota. It is affiliated with the Evangelical Lutheran Church in America. He then went to a junior college the next year, as he was figuring out what he wanted to do

professionally. He started working one summer in Collections and did not return to graduate. He worked for Interstate auto group DBA CarHop - which did subprime in-house lending to credit and income challenged customers. He started in collections - spending 8+ years in leadership running a collections team. He was then recruited to the position of sales district manager. CarHop brought him to Seattle to run the district on the finance side. After one year as Collections Manager, he was recruited to the sales side.

In 2023, he moved into a new industry. He is a Senior Account Manager at TKElevator, managing a portfolio of properties (elevators). This involves handling service contracts and repair sales, along with some modernization. Established in 2013 TK Elevator installs, maintains and modernizes elevators and escalators. It is a worldwide company.

You might have noticed in his bulletin bio that Sam is a competitive bicycle racer. His first major out of town race was in St Louis. It was an omnium (three race series) time trial and two crits (Criterium races). A crit takes place on a closed 0.6-1 mile course and races last 60-90 minutes. Typically, 100-150 riders participate. The race is characterized by speed, intensity, and excitement. The winner is the first ider to cross the finish line without being lapped. Sam won both crits in front of his mom and won the Omnium to upgrade to a Cat 3 at the time. There are 5 categories of racing: Categories (CAT) 1-5. Racers start as a 5, then through results and points move up the categories.

In Seattle, a friend invited Sam to do the STP (Seattle to Portland) with him in 2018. From there his passion grew for cycling and competitive amateur racing. Sam races as Category 1 (Cat 1)--the highest racing category in USA Cycling.

I asked: What bikes do you race? Sam currently owns 5 bikes--3 road and 2 track bicycles. Specialized, Cannondale, Focus and Dolan.

I'm sure this is something our avid U Rotary cyclists will want to talk about with Sam.

Our next volunteer opportunity at the House will be in November 2024.



### International Service Committee—Senegal Project Progress Report

In the 2022-23 Rotary year, our club's ISC contributed \$3,000 toward a Global Grant project in Senegal, sponsored by the Bellevue Rotary Club. The goal of the multi-year \$114,000 project is to provide water, food security, and economic development for the 250 people who live in the village of Keur Birame.

The steps of the project involve rehabilitating an abandoned water well and installing a solar pump and gravity-fed garden irrigation system to provide access to clean water for the community. Then, hands-on coaching in sustainable agriculture strategies provided the necessary elements for community members to start growing fresh, nutritious vegetables year-round for the first time. Soon they will also enjoy improved household incomes and economic security, through the marketing and sale of the vegetables. Finally, participants will be taught how to develop a community fund to support the long-term maintenance of their garden and water source, thereby improving water and food security and economic sustainability.

Recently, David Laub and Fred Auch of the Bellevue club visited and were pleasantly surprised to see how



much the community has already achieved in just a few months. The village now has abundant water and a thriving community garden, producing and harvesting nutritious vegetables over several harvest cycles.

# **Rotarians Receive Paul Harris Fellow Awards**

On Friday, August 23, Rosemary Aragon presented three Rotarians their recently achieved Paul Harris Fellow awards. Kirk Laughlin received his PHF+1 and Marisa Broggel and Tabitha Claus (Seattle 4 and meeting speaker) both became new Paul Harris Fellows (PFH).

As reported in our August 23 bulletin, Stephanie Feldt also

received her first Paul Harris Fellow award on August 12, at the Oaxacan dinner at Rosemary's house.

Rotarians become Paul Harris Fellows when their contributions to The Rotary Foundation

(TRF) reach \$1,000. Multiple PHF awards are given for increments of \$1,000. These awards can be achieved through both monetary donations over time or with "recognition points." In her

presentation of the awards to all three newly minted Paul Harris Fellows, Rosemary noted that she had topped up the awards for all of them with such points.

So, what is a recognition point and what can Rotarians do with them? Recognition points work like Alaska Airlines credit card mileage awards. For a mileage award, if you spend \$1,000 on goods, Alaska then credits you with 1,000 miles that can be used, along with other miles, to purchase an Alaska flight.

In the same way, each dollar donated to TRF for the Annual Fund, PolioPlus or a Foundation grant also results in one recognition point. These points can be transferred, in 100-point increments, to other individuals to help them reach their TRF giving goals, e.g., to become

a PHF or to reach the next level of giving. For example, if an individual Rotarian has donated \$600, another Rotarian with accumulated points can transfer 400 points to them, to equal the 1,000 needed to become a Paul Harris Fellow.

All of us who have donated to TRF can find out how many points we have via our My Rotary account at www.rotary.org. Click the down arrow to the right of My Account in the upper right-hand corner to see My Donations—for dollars and points, as well as the form required to make a points transfer.




