The organization's mission "is to provide and facilitate access to justice in Clark County for low income individuals and marginalized communities through advocacy and civil legal services."

Ben will be telling us about housing justice casework, which includes landlord/tenant disputes, evictions, tenant discrimination, or any issue that prevents a client from being safely and fairly housed. The volunteer attorneys provide advice during clinic appointments and may provide assistance at the unlawful detainer (eviction) docket.

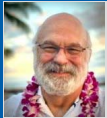
