



Featured Speakers Mark Birge Chair, Rotary Foundation Committee



Mark Birge, the Club's Foundation Chair, explained the ins and outs of Rotary Giving. He divided his talk into the What, Why, and How.

WHAT: When a member of the club contributes to the Rotary Foundation (not the club foundation), the money needs to be designated to one of three buckets:

- 1. Polio Plus: Funds are dedicated to the eradication of Polio from the world. Contributions are matched 2:1 by the Gates Foundation.
- 2. Endowment: Funds are invested, and the interest is used to supplement the Annual fund in supporting projects locally and around the world via grants. Current Endowment balance is \$1.3 Billion.
- **3. Annual:** This is the main area that funds Rotary projects locally and globally. The funds are invested for 3 years, and then divided equally into:
- World Fund: supporting Global Grants in one of 8 areas of focus.
- **District Grants:** supporting projects locally, and approved by the District.

WHY: Several members of the club, described what it means to give to TRF.

Linda Brown: Reasons for giving are; personal experience with Polio survivors, the importance of education in her life, and projects she is involved in, like the Dictionary project.

Jackie & Curtis Schade: Reasons for giving to TRF are; It's easy, it's a stable investment, supporting Service Above Self, and it's just "The right thing to do".

Paul Graham: Want to see a healthy planet through environmental projects globally. It's money well spent, with low overhead. It's "antideprsent" – contrasting all the bad events in the last 2 years.

HOW: Mark declared our club as "generous" in giving, averaging \$593 per member, per year. There are 121 PHF members out of 146 total.

The Foundation Committee goals are;

- 1. Make it easier to give
- 2. Educate and provide feedback
- 3. Provide matching points from the club to help members become Paul Harris Fellows.

Club Goals: 100% PHF and 100% of members giving at least \$25/year
