Mark, alongside his partner Carolyn, embarked on a new adventure. They purchased ten acres in rural Oregon, laying the foundation for the School of Ranch. This venture marks a continuation of Mark's lifelong commitment to innovation, education, and community. Do you provide care for an elderly family member? How many of your friends assist older relatives?



Dr. Richard Schulz is a Distinguished Service Professor of Psychiatry, Emeritus at the University of Pittsburgh School of Medicine. For over 30 years his research focused on the effects of disabling late life illnesses on patients and their families and strategies for mitigating the adverse health

effects of caregiving.

More than 17 million family and friends provide unpaid care to older adults. The value of this "free†care exceeds \$500 billion annually.

On Tuesday, January 23rd at 7:00 p.m. at The Belfry, Dr. Schulz will present his lecture titled "Family Caregiving in the US: Research, Policy, and Future Directions.†This talk examines the emergence of caregiving as a major public health issue in the US.

Join the Sisters Science Club for this segment of the Frontiers in Science lecture series to review the nature of the caregiving experience, how it has changed over time, it's impact on family/friends, and strategies for mitigating the negative health effects of caregiving on both caregivers and their care recipients. The speaker will review some of his own research in this area and it's impact in shaping national policy on family caregiving.

The social hour begins at 6:00 p.m. with light fare, beer, and wine available for purchase. Admission is \$5 at the door; teachers and students are admitted free. The Belfry is located at 302 E. Main Ave., Sisters.
