# Sheriff's K-9 Unit – Yahtzee!!!






Scott said ten new members would be a fine goal for this year.

Melinda Ciarabellini shared about her recent Disney Cruise, with all five grandchildren. Unfortunately, she and her husband got COVID and spent half the cruise sequestered in their room. They were very grateful for room service! Scott fined Melinda \$50, to match Marie, to go to the Foundation.









Dan Brown was today's lucky raffle winner, but because he was on his phone, he almost missed it when Scott called his number. Despite this, he managed a full house. The dice were with him, apparently. The full house winnings of \$20 were donated to the club, which per Scott, was the cost of being on his phone during this very important drawing.







Our Program was presented by Marty Coehlo. Marty is the College of the Redwoods Executive Director of College Advancement & the CR Foundation. He and his wife moved to Humboldt County in 1991, have four children, and have been active in the fights against Cancer and Alzheimer's here. Marty presented on the goals on the foundation, which include establishing the relevancy of the foundation within our community; promoting the funding of scholarships, internships and special projects; and facilitating partnerships within the community in order to focus on student enrollment and success, workforce and economic development, community health, and equitable opportunity. CR gives out nearly one-half million dollars annually across nearly five hundred awards from the four million dollars CR currently has invested in the scholarship fund. As far as Marty is aware, CR was the first college/university in the country to establish a scholarship fund for housing-insecure/homeless students. CR provides one month's rent-free in the residence halls, and a meal program, and then tries to move these students into outside housing. These students are showing incredible initiative and resilience in pursuit of furthering their education and improving their lives. Many of these students are emerging from past addictions or other traumatic life circumstances. The graduation success and/or rate for these students is 66%. CR has a Creative Arts building currently under construction, which will be finished by early summer 2023, or by spring of 2024 at the latest. CR is also building new residence halls, as well as a new athletic center and field house. Marty also spoke to the critical need to close the gap between traditional and non-traditional educational systems. A Google certificate in web design, for example, may work well for a person who is already mature enough to understand what businesses will require, but is not likely to work for a person without that maturity and who lacks the required skill sets required to be an employee someone would want to hire and retain. Every business in Humboldt County has the same frustrations: They can't find anyone to hire; they don't pass the drug test; they don't understand workplace norms, e.g., "you must show up on time and actually work;" they don't understand customer service. Another challenge is how to recruit and retain competent nursing faculty, when those trained in nursing can work elsewhere for three times the pay.

Scott closed the meeting with this profound bit of wisdom: "Bus your tables!"
