Ed Martin Honored by the Germans from Russia Heritage Society



Congratulation Ed!!

On July 18th, 2025, fellow Rotarian, Ed Martin was awarded the Joseph S Height Literacy Award in appreciation of his contribution to the preservation of our ethnic heritage through his contribution "Orrin, Family, Church, and Community". The prestigious award was made at the 54th International Convention of Germans from Russia Heritage Society. Ed's article was published in the Heritage Review, a magazine publication of the Germans from Russia Heritage Society. Orrin, ND is where Ed grew up and the homestead of his grandparents, immigrating to the U.S. in 1909 from the Black Sea area of South Russia,

which is part of Ukraine today. Orrin is now an abandoned community, like many rural towns in America. The article "Orrin, Family, Church, and Community" is a chapter in a book Ed is writing called "Adapting to Change," about his experiences of Times, Places, and Events. It is a book requested by his children and family and not published for further distribution.

Estate Planning Basics by Kim Guthrie

Kim Guthrie, with Newman, Conley and Ruth, shared with the club some basics of Estate Planning. Disclaimer: not to be taken as legal advice. Everyone's situation is different, hence your estate planning with an attorney should be tailored to each individual's life situation. Key points:

- Probate - you want to avoid this! It's a lengthy, time-consuming court process. Fees are expensive. A Will alone does not avoid probate.
- Ways to avoid probate? Non-probate transfer to a Trust where you can retain control over assets after you pass. The administrative cost of a trust is less. There are several different kinds of Trust, so get with your attorney to see which is best for you and your family.
- Other estate planning considerations include Power of Attorney for financial and health care directives.

If you already have these documents in place, have you reviewed them recently? Are they current and still reflect what you want to happen when you pass? It's always a good idea to dust these documents off and review them. It's also important that members of your family know what your plans are and where the original documents are kept. And if you have not explored estate planning yet, but want to, there are many good attorneys that do estate planning, three of which are in our club (Kim Guthrie, Stephen Stark and Jon Browning)!
