Program Preview

David Spicer joined the staff of the United States Conference of Catholic Bishops in the fall of 2020 as a Policy Advisor in the Department of Migration and Refugee Services. In this role, Spicer provides the Conference and the Bishops with policy analysis and recommendations on immigration issues, represents the Conference in coalition work and at national and international meetings on these subjects, and, as required, delivers congressional testimony, reports, advocacy papers, backgrounders, and action alerts.

Since assuming his position, Spicer has overseen two amicus briefs. The first, *Trump v. New York*, involved the Trump Administration's stated policy of excluding undocumented persons from the decennial census data used for congressional apportionment. The second brief was for *Pekoske v. Innovation Law Lab* (formerly *Wolf v. Innovation Law Lab*), which hinged on the legality of the Migration Protection Protocols (MPP).

Spicer was awarded a summer fellowship opportunity from the Notre Dame Program on Church, State & Society while a student.

"Notre Dame's Catholic character was always my primary motivation when it came to where I would attend law school. Any school can produce competent lawyers, but very few institutions see the law as a solemn vocation and cultivate that view in the minds and hearts of those they serve. This is what sets Notre Dame apart from its peers, and it's what allows ambitious enterprises, such as the Program on Church, State & Society, to thrive. I'm indebted to the Program—and its generous benefactors—for the opportunity to work at the USCCB while in law school. Otherwise, I never would have made the lasting connections and gained the valuable experience necessary to secure such an impactful position," said Spicer.

Gifty Benson is a retired Pediatric Dentist and teaches college courses part time on Human Anatomy, Human Physiology and Biology in Oklahoma. She is also the head and founder a nonprofit group *African Hospitals Foundation,* which

is 501c3 accredited. Their mission is to build and refurbish clinics in the rural areas of Ghana, West Africa to reduce morbidity and mortality.


