### About the Program: Arkansas's Defense Industry Panel

Camden and South Arkansas began playing a vital role in our nation's aerospace and defense industry as far back as the 1940s. Since the Shumaker Naval Ammunition depot was built in Ouachita County for \$60 million, the area has grown to employ more than 3,000 people working for more than 30 defense and aerospace companies and support businesses.

Highlighting the future of the aerospace and defense industry in Arkansas, with a look back at the past, will be the focus of Tuesday's Club 99 panel discussion.

Panelists Chandra Hooker, senior director and Site Executive for Aerojet Rocketdyne in Camden; John Schaffitzel, president of the Highland Industrial Park; and James Lee Silliman, executive director of the Ouachita Partnership for Economic Development (OPED) and the Camden Area Industrial Development Corporation (CAIDC), will be part of a discussion Tuesday moderated by the Arkansas State Chamber of Commerce's Andrew Parker. ### About the Panelists and Moderator:

### Chandra Hooker, Senior Director and Site Executive, Aerojet Rocketdyne

Hooker serves as the senior director and Site Executive for Aerojet Rocketdyne's Camden Arkansas site. She is responsible for providing the people, processes and infrastructures required to safely and successfully manufacture, test and deliver Aerojet Rocketdyne's products. She joined Aerojet Rocketdyne and the Aerojet Rocketdyne Camden Team in July 2021.

The former manufacturing engineer with 3M has more than 20 years of leadership experience in the defense industry in manufacturing and construction operations, including serving as a construction superintendent for the Virginia Class Submarine Program.

### John Schaffitzel, President, Highland Industrial Park

Schaffitzel is president of Highland Industrial Park, East Camden Highland Rail, and Highland Deephaven. He is responsible for the day-to-day operations of Highland Resources, Inc.'s largest asset, including the direct supervision of onsite employees, chief negotiator on terms of leases and agreements with tenants and third-party vendors, along with building and maintaining those relationships. He is the driving force of profitability in real estate, facility management, finance and operational asset management.

Prior to joining Highland Resources, Schaffitzel was executive director of real estate and development for MidAmerica Industrial Park, in Pryor, Okla.

### James Lee Silliman, Executive Director, Ouachita Partnership for Economic Development

Silliman currently serves as executive director of the Ouachita Partnership for Economic Development (OPED) and the Camden Area Industrial Development Corporation

(CAIDC). He assumed the position of executive director of OPED on June 1, 2015, and had previously served as executive director of the CAIDC since July 2007. He was designated a Mid-South Economic Development professional in 2011 by the University of Arkansas Little Rock's College of Business, Institute for Economic Advancement, after successfully completing various courses of study at UA - Little Rock. He also completed the Community Development Institute at the University of Central Arkansas in Conway in 1994.

Silliman is a lifelong resident of Camden and has served in many community service capacities in Camden spanning the past thirty-eight years, including mayor of Camden, Camden City Board of Directors, Camden Area Chamber of Commerce Board, Main Street Camden Board, Southwest Arkansas Planning & Development District Board, Arkansas South Tourism Board and the Ouachita County Historical Society Board of Directors.

### Moderator Andrew Parker, Director of Governmental Affairs, Arkansas State Chamber of Commerce

A licensed attorney and graduate of the William H. Bowen School of Law, Parker is part of the state chamber's governmental affairs team and works to enhance the business climate in Arkansas by representing the positions of the chamber and Associated Industries of Arkansas Foundation, Inc. before entities including committees, boards, various state agencies, the governor's office and the legislature. He is the executive director of the AIA Foundation and has led the Be Pro Be Proud Initiative since its launch in 2016.

Parker previously served as regulatory counsel for the Arkansas Oil and Gas Commission and the Arkansas Game and Fish Commission.
