### It's time again for Community Grants Applications!

*We are now accepting applications through September 1, 2022.*

*The following are some general guidelines (for more details on the guidelines, please see our [Community Grant Review Process Document](#) (click to download)).*

- Applications must be submitted by a Carmel Rotarian on behalf of a charitable community organization (the Rotarian may not be a salaried employee of that organization).*
- Each grant will be capped at \$1,000.00 per organization.*
- Organizations may be awarded only one grant in a twelve-month period.*
- The organization must be in Central Indiana and provide their charitable service for Central Indiana. Preference will be given to organizations which serve the underserved/underprivileged groups in Carmel or Hamilton County.*
