Vols' NIL Expert Shares Her Expertise On This New 'Game'

In this new world of college sports, it's known as "NIL" and players on many campuses are starting to make money, some big money, based on their individual NI&L. The University of Tennessee is fertile ground for this game, too.

It's a topic many fans do not completely understand. Are collegians becoming professionals? Is that line forever blurred? How does NIL and this money factor into

recruiting? Will college athletes have agents while they are in school now? Will it create issues between players who make money and those who don't?



Our program Wednesday will be all about NIL at UT. The speaker will be **Katheryn “Kat” Jones**, who joined UT in September 2021 as the Director of Name, Image and Likeness. Prior to moving to Knoxville, the Pensacola, FL native spent more than two years as assistant director of compliance at the University of Central Florida (UCF). Jones earned her Bachelor’s degree in Business Administration/Marketing from UCF and graduated from the Mississippi College School of Law in 2019.

She manages NIL education, monitoring and support efforts for UT’s 20 varsity sports and more than 500 student-athletes. A key part of her job is compliance – working closely with the athletics compliance staff to oversee agent registration and ensuring NCAA, SEC and institutional policy adherence.

Tennessee Athletics also has initiated multiple strategic partnerships in addition to securing the services and expertise of the NIL-focused firm Altius Sports Partners. UT also worked closely with on-campus experts to enhance the university’s for-credit Entrepreneurship minor in UT’s Haslam College of Business.



Sarah Pass Educates Us About CADES

Sarah Pass has found where she needs to be — and that's as the Executive Director of the **CADES** program at Concord United Methodist Church. “This is where I need to be,” she told us Wednesday as our speaker. “I was at NHC Farragut in a social work slot and it was not what my heart was in. I was led back to CADES.”

CADES — Concord Adult Day Enrichment Services — began in 2005 as a community service to area elderly regardless of religious affiliation. It is a daytime structured program of services and activities for senior adults in need of care, social contact, and supervision because of either physical or mental functioning impairments. CADES also provides support, education and respite for caregivers.

Pass (pictured here with President David), who has been leading this non-profit for six months, says it serves 10 to 12 seniors daily and around 16 seniors a week with various forms of dementia. “On the flip side we’re providing support and respite and rest to the caregivers. It takes a toll on people being a caregiver and working in their home,” she explained. “It affects them emotionally, physically and financially.”



The program runs from 8:30 a.m. to 4:30 p.m. Monday-Friday serving 20 families. They currently have a waiting list of 15 families.

One of their primary goals is to keep their clients from premature institutionalization into assisted living, skilled nursing or nursing homes.

Tax-Deductible Donations To RCF Foundation Can Support Julie & Kids

We still do not know when **Julie (Yuliia) Tryukhan** and her two children, still in Zilina, Slovakia, will be coming to the U.S. They have been approved and authorized to travel under the Uniting for Ukraine (U4U) process. This week PP Jim O'Brien, president of our Rotary Club of Farragut Foundation, shared some very good news with us about supporting Julie and family.

"The RCF Foundation needed to get an official ruling on whether we can use Foundation funds to support a single Ukrainian refugee family and we asked this question to our accounting and tax consultants at Coulter & Justus, P.C. (C&J)," Jim said. "They reviewed IRS Publication 3833, Disaster Relief as well as other pertinent regulations. I received an e-mail from C&J with their determination. The concluding sentence stated: "We believe any Ukrainian refugee's family circumstances would easily be understood to meet the needy or distressed test."



So, with that ruling we're assured that the RCF Foundation can do what's necessary to receive tax-deductible donations (cash and in-kind) and expend those funds in support of Julie and her family, donations from members and from others who want to contribute to supporting them.

"While we wait, let's all keep Julie's husband Dima (and his comrades-in-arms), Julie, Polly and Mark in our thoughts and prayers," Jim added. Dima is in the Ukrainian Army battling the Russians.

Julie, now 32, was a Rotary Youth Exchange (RYE) student sponsored by our club in 2007-2008 and attended Webb School.

For Women: A recent study from England comparing 43,000 women with breast cancer to 431,000 non-breast cancer controls found that postmenopausal estrogen use is not associated with an increased risk of developing breast cancer. However, use of synthetic progesterone was associated with a 28% increased risk of developing breast cancer. Here is a [LINK](#) to the study.

For Everyone: Vitamin D deficiency in the elderly is common, probably from lack of sunshine which is how the body produces vitamin D. A recent study showed that high-dose vitamin D supplementation in the elderly suffering with COVID decreased mortality by half.
