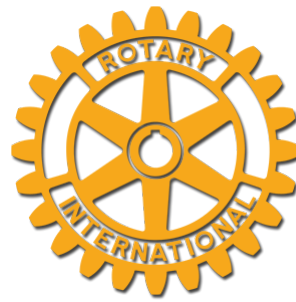

23 03 13 Jeremy Griem Executive Director of Metro Changers

Jeremy Griem serves as the Executive Director of Metro Changers. In 2007 Metro Changers (www.metrochangers.org), a nonprofit in partnership with the Birmingham Metro Baptist Association, was formed to work with the city of Birmingham through the utilization of volunteers to improve housing for low-income residents of Birmingham and share the love of Christ through giving and caring. Metro Changers improves the housing conditions for those in the Birmingham community who are most in need: low-income homeowners, the elderly, those with disabilities, people with health problems, and veterans or spouses of veterans. Metro Changers repairs or replaces roofs, paints houses, repairs or replaces decks, and builds accessibility ramps.

Prior to working with Metro Changers, Jeremy served as the Missions Pastor at Shades Mountain Baptist Church in Vestavia Hills for over 17 years. In that role Jeremy oversaw all local, national, and international mission work for the church. During his time on staff, Jeremy lead 21 national church planting partnerships, help send over 1,500 volunteers out on short term trips annually, and traveled to 58 countries with short term teams.

RCSV 2023-2024 Board Changes

Your leadership for the next Rotary year, 2023-24 was convened in a special call Board meeting, Friday March 3 for the purpose of filling two vacancies. All members of the Board but one are elected by the membership at the annual meeting of the club in December. The exception is the office of Sergeant-at-Arms (SAA) which is elected by the Board itself. That vacancy plus one recently created by the need for Erica Murphy to step aside from the previously elected position of President, 2024-2025 (PE for 2023-2024) for personal reasons were acted upon in the meeting.

1. Elected, by unanimous voter, to serve as SAA was John Beard.
2. William Wentowski was requested to vacate his elected position of Secretary/Treasurer and accept nomination for the position of President 2024-25. No additional nominations were offered and William was elected by unanimous vote.
3. Bill Dean was then asked to vacate his elected office of Director of Administration and accept nomination to serve as Secretary/Treasurer. No additional nominations were offered and Bill was elected by unanimous vote.
4. Lastly, Ashley Neese was nominated to serve as Director of Administration. No additional nominations were offered and Ashley was elected by unanimous vote.
