# New RCSV Payment Policy

Thursday, August 11, 2022

As announced by President Chatterton, your Board has adopted a new Invoicing and Payment Policy. The exact language of the policy is copied below. Additional information may be read by clicking the 'Read More' button.

## Invoicing and Payment Policy Effective July 15, 2022 Rotary Club of Shades Valley

- All new invoices will be issued with terms of 'NET 15 DAYS'.
- Invoices may be rendered at any appropriate time.
- Beginning with the invoicing cycle for October through December 2022, quarterly dues, assessments, voluntary contributions, etc – Invoices will be issued 15 days prior to the first day of the first month of the quarter.
- Invoices are expected to be paid within 15 days of the invoice date.
- Invoices 30 days past due- Members will receive a statement, a gentle reminder and request to pay
- Invoices 60 days past due- Members will receive a sterner reminder, a statement, a copy of this policy and advisal of suspension\* if not paid within the next 30 days.
- Invoices 90 days past due- Members will be suspended\* from services of the RCSV, will receive a statement of account, a request to pay and a warning that if not paid within next 30 days, membership in RCSV and Rotary International will be terminated\*.
- Invoices 120 days past due- Membership is terminated\*.

Accounts with past due balances as of July 15, 2022 have 90 days to bring the account current / make suitable arrangements with the Secretary/Treasurer or suspension may apply. Such accounts have 120 days to bring accounts current/make suitable arrangements or termination may apply.

\*All suspension and termination steps are subject to waiver by the Board

The first invoicing under the new policy is scheduled for Thursday September 15 with terms of NET 15 days and due September 30.

As of today, we still have members with past due balances from the current quarter and beyond. Please note that the provisions of the new policy provide for the 90 days past due actions to be implemented effective October 15 and the 120 day provisions November 15. Please help your club leadership, your fellow members and yourself by remitting payment today!
