Judge John Breakfield

John Breakfield was elected to Hall County State Court in 2016 in a contested election and re-elected in 2020. As a judge, he handles both civil and criminal jury trials, arraignments, legal motions, non-jury trials, bond hearings, probation revocations, and various other legal matters. Judge Breakfield has presided over 65+ jury trials.

On the statewide leadership level, he is a member of the Executive Committee of the Georgia Council of State Court Judges, the District Chair for his region, and on the Legislative Affairs Committee. In these roles, he assists the Council of State Court Judges on administration, policy, and recusal appointments.

Prior to taking the bench, Judge Breakfield owned and managed his own law firm and handled both civil and criminal matters for individuals and small businesses. He also served as the prosecutor for the City of Gainesville Municipal Court, Assistant City Attorney for the City of Gainesville, and taught paralegal classes at the University of North Georgia.

Prior to law school, Judge Breakfield was a Taco Bell manager where he learned the importance of customer service and hard work. Judge Breakfield lives in Flowery Branch with his wife Astrid and their two wonderful sons.

Judge Brian Heck

Brian Heck has been an Associate Magistrate Court Judge since January 2022. Prior positions include Vice President and General Counsel for a lawn and garden distributor, Owner/attorney of Heck Law Firm, Assistant Hall County Solicitor General, Staff Attorney for Honorable Clint Bearden (Superior Court Judge for Hall and Dawson Counties), Assistant District Attorney in Hall County.

He earned a bachelor's degree in history from LaGrange College and a law degree from Atlanta's John Marshall

Judge Heck and his wife Emily have two daughters: Olivia and Lindsey.

Judge Patty Laine

Patty Laine was born and raised in Gainesville, Georgia. After graduating from Gainesville High School, she earned a bachelor's degree in political science from Furman University and a law degree from the University of Georgia School of Law. Carol M. Colón Circuit before spending 10 years practicing law in Gainesville. In 2012, she was elected Probate Court Judge and was reelected in 2016 and 2020.

Judge Laine is committed to her community and volunteers through various organizations, including being a troop leader for Girl Scouts of Historic Georgia for the past 16 years and through her church, St. Paul United Methodist. She is also a member of the Northeastern Circuit Bar Association and is involved with leadership in the Council of Probate Court Judges of Georgia. She is past chair of the Council of Probate Court Judges Training Council and currently serves as Vice President of the Council of Probate Court Judges. In 2022, Judge Laine was named Outstanding Probate Judge of the Year by the Council of Probate Court Judges and, in 2023, was given the Special Recognition Award by the Council.

Judge Laine and her husband Jesse have 2 adult daughters.

Judge Alison Toller

Alison W. Toller is a judge for the Northeastern Judicial Circuit Juvenile Court in Georgia. She was appointed to the bench by a panel of superior court judges in 2014, filling a vacancy created by the retirement of the Hon. Cliff L. Jolliff. Prior to her appointment, Toller was an attorney at the Weaver Law Firm in Gainesville, a position to which she was selected in 2013.

Toller earned a bachelor's degree in economics and political science from Emory University in 1996. She then completed a J.D. at Georgia State University College of Law in 1999.

After graduating from law school, Toller began her legal career as an assistant solicitor general for the DeKalb County Solicitor-General's Office in 2000. However, her time there was brief. Later that year, she moved to Hall County, where she joined the Hall County District Attorney's Office as an assistant district attorney.

Judge Jason Deal


Jason J. Deal was appointed Judge of the Superior Court of the Northeastern Judicial Circuit of Georgia by Governor Sonny Perdue effective June 22, 2005, and ran unopposed for re-election to the post in 2006, 2010, 2014, 2018, and 2022. Deal became the presiding Judge of the Hall County Drug Court in January 2006 and started the Dawson County Treatment Court (Drug/DUI) in July 2006. The Dawson County Treatment Court now includes DUI, Drug and Mental Health tracks. In 2013, Deal started the Hall County Probation Drug Court. Today Deal shares duties with Judge Clint Bearden in the Hall County Drug Court. Deal presides over Alpha Track and Bearden presides over Bravo, and Charlie Tracks. Deal also served as the first chairman of the Georgia Council of Accountability Court Judges from 2015 to 2017. He was a member of the Governor'S Criminal Justice Reform Council from 2012 to 2018 and the Georgia Criminal Justice Coordinating Council from 2015 to 2017. In 2017, Deal received the Emory Findley Award from the Georgia Council of Superior Court Judges. He formerly served as Chair of the Accountability Courts Committee of the Council of Superior Court Judges and on the Supreme Court'S Justice for Children and Families Committee. In February 2024, Deal became the Chief Judge of the Northeastern Judicial Circuit.

Prior to becoming a Superior Court Judge, Deal served as District Attorney of the Northeastern Judicial Circuit from May 1, 2002, until June 2005. While serving as District Attorney, he was involved in the planning and implementation of the Hall County H.E.L.P. court and served on the Georgia Crime Information Center Advisory Council. He also previously served as a Magistrate Judge in Hall County, and as an Assistant District Attorney for Hall and Dawson Counties. As an ADA, Deal received the 1999 Work Horse of the Year award. Deal also worked as an associate in the Dawsonville branch office of the firm Fox, Chandler, Homans, Hicks & McKinnon and served as County Attorney for Dawson County.

Deal is a long-time resident of Hall County, having graduated from North Hall High School. Deal obtained a Bachelor of Science degree from Furman University and his law degree from the University of Georgia. Deal also served honorably as an active-duty infantry officer in the United States Army.

Deal is the son of former Governor Nathan and Sandra Deal. He is married and has three children. He is a member and past deacon of the First Baptist Church of Gainesville, Georgia. Deal works on his small cattle farm in his spare time.
