MEETING June 24, 2024

Attendance: 62.4% - 62 in person, 14 Zoom, plus 9 guests

Stephanie Folsom rang the bell to start the final meeting of her term as President. After reminding us of our club's 110-year history of service, she thanked Jackie Riley for her piano playing. Jackie received a standing ovation.

Jeffery Monroe, with his wonderful singing voice, led us in *God Bless America*. Past President Charlie Jay then offered the prayer, prefacing it with his signature line, "Whew! It's a great day to be alive!" He offered appreciation for the incoming and outgoing Rotary leaders and all who believe in serving others rather than standing on the sideline and waiting to be served.

Stephanie welcomed the many guests in attendance, which included spouses and family of members. Stephanie's family was well-represented by her husband, father, mother, stepson and daughter-in-law, and a dear friend.

Four Rotarians celebrated birthdays last week, and three more this week. Five members have club anniversaries, including Van Van De Water with 14 years.

It was then time for CART brags, and we had some notable ones. Most importantly, Kathryn Dennis was back for the first time in a while after undergoing treatments. She received a warm ovation from the members.



Stephanie then said this is not only her last day as serving as President but it is Cecil Coke's last day serving our club, which he has done since 1991. That is 33 years of service! Cecil was expected to joini us today through Zoom, so she welcomed Cecil.

Stephanie continued, "It would not be right for us let today go by without saying **THANK YOU Cecil....** for the endless hours of service and dedication to the operations of this club.

"During his time with our club he was club secretary and held treasurer duties. He is a Major Donor and a Bequest Society member of the Rotary Foundation, a Paul Harris Fellow, and a GRSP Hue Thomas Fellow, Kendall Weisiger Fellow and Will Watt Fellow.

"Cecil transferred his membership to the St. Simons Island club in 2022, however_he kept serving our club with treasurer duties, overseeing collection of dues, CART and writing checks for our club and I am sure there are many other things that I am not aware of that Cecil has been doing to help our operations.

Jim Manley:

Serving on the Board multiple times and ultimately serving as Club President afforded me the opportunity to work closely with Cecil, a man I admire on both a personal and professional level. Beyond his obvious strengths of business acumen and technological proficiency – which



benefitted the Club for decades – Cecil was also vigilant in protecting the Club's future by demanding we respect its past and always uphold Rotary ideals and values. On a personal level this was embodied most through his generosity, which reached major donor and leadership levels with the foundation and most other Rotary areas of focus for giving and in doing so set a great example for everyone.

It was then time for a Paul Harris Fellow presentation to Dr. Chris Blake. President Stephanie reminded the club that Paul Harris recognition was established in 1957 to show appreciation for substantial contribution to the Rotary Foundation. The gifts to our foundation represent more opportunities to do more good here at home and around the world. The Foundation raises over \$70 million annually and 80% of those funds come from Paul Harris fellow contributions

Today there are over 1.5 million Paul Harris Fellows. Many notable figures have been named Paul Harris Fellows including President Jimmy Carter, US Astronaut Jim Lovell, and Polio Vaccine developer Jonas Salk.

Stephanie then came back to the podium to say some final words as President. Below is the text of Stephanie's "Farewell Address:"

During his career Danny has served on numerous boards, on both a local, state and national level. He has spoken at a national level on subjects such as attracting, acquiring, and retaining talent,



apprenticeship, Industry safety, and understanding human behavior as it aligns with a career.

He currently serves on the Navicent Foundation Board where he chairs the Major Gift committee, as well as the United Way of Central Georgia Board. In addition, he assists in securing funding for: The Museum of Aviation, Me Over PD (which is a local foundation assisting Parkinson's patients and their caregivers), and Glad Rags. Married to his wife Terri for 44 years. they have two children, Betsy and DeKalb, both of whom are married, and three of the cutest, and smartest grandchildren - Walter, Dorothy, and Harris.

District Governor Felix Smith then came up to formally swear Danny in as the 110th President of the Rotary Club of Macon. After he was sworn in, Stephanie announced they would do a "passing of the gavel" ceremony, where all the former presidents in the room would come up, line up in chronological order, and hand the gavel to Danny. In addition to Stephanie, 13 former presidents participated, along with District Governor Felix Smith.

New President Danny then came to the podium. He said that as everyone today has given accolades to Stephanie and the Board, it made him think about his two children. Both are extremely intelligent, with almost perfect SAT scores. His daughter was valedictorian of her High School class and finished third in her class at Tulane His son, who two and a half years younger, when he started to go to college he told his Dad they needed to have a meeting. When Danny asked what was on his mind, he said, "Dad, I just need to tell you that Betsy has set the bar higher than I plan to achieve." Danny said the bar was, indeed, high, but that he would strive to reach it.

Danny credited his wife, Terry for much of his success. He thanked Susan Welch, saying that when you are elected president of the Rotary Club of Macon, you begin a three-year stint, and you start that really 3-6 months before you start your three-year stint. So it's a 3-and-a-half-year process, beginning







with President-elect, then President, and finally past President. Danny also thanked the 2023-24 board, and said that starting with first President John W. Hancock to Stephanie Folsom, with 107 individuals between them, they all carried out their duties in a well-fashioned manner. And not to take anything away from the others, but Stephanie has done a magnificent job, with extraordinary organizational skills coupled with a leadership quality which is rare.

Danny then asked Stephanie's husband, Miki to come up and pin on Stephanie the "coveted" Past President's pin. She was also presented with an appreciation gift.

Danny said we all should take pride in the great foundation of our club, laid down by those members that served before us. "Over the past 6 months I've been privileged to attend several educational and training events, programs, and seminars to prepare me for this presidential role. During these sessions I met many individuals and learned information about other clubs in District 6920. These, too, helped reinforce my appreciation for our club. The organizational structure, the operating procedures, and the processes that we have in place are extraordinary."

He asked all the members to stand together to make the 2024-25 Rotary year exciting and productive.

After reminding the members that we have no meeting next Monday, Danny asked Katherine McLeod to come up and conduct the lottery drawing. District Governor Felix selected the ticket, which was held by George Lee. George drew the Queen of Hearts, which would have been a winner in past lotteries but this time the Queen of Clubs is needed! The \$515 jackpot rolls over to the next meeting.

HOW TO MAKE UP MISSED MEETINGS

Please make up missed meetings to help our club's attendance percentage rank with District 6920 and Rotary International. Our attendance is reported each month to the district and is required to be reported before the 15th of the following month. **Members are encouraged to maintain an attendance average** of 60%.

Missed meetings must be made up 14 days before or after the meeting you miss.

You can make up from the comfort of your home or office online at http://rotaryeclubone.org/ They will email a notice of the makeup to the Club Administrator and you will be credited. Also, attendance at another Rotary Club is a great option when you are traveling!

When you make up using the **Zoom link** of our meetings listed in meeting summary above or makeup in person at another club please send an email immediately afterwards to the Club Administrator, steve@eggmedia.com so your makeup can be recorded. Do not expect the club you visit to report to our club.

Excused Absences

Members have the opportunity to receive a board approved Excused Absence during a long-term family, health, or business crisis. When a member realizes they have a situation that will keep them from attending Monday meetings for an extended period they can contact the Club Administrator or President with the reason. This contact needs to be immediate and not after the crisis. The board can approve a beginning and ending date and attendance is excused on club and district level. Short term absences are best made up online.

Club Membership Applications

We are purpose-driven leaders of influence and action. To sponsor a prospective candidate to join our membership, contact Membership Chair Charles Olson EOlson200@msn.com or any member of the Board of Directors to ensure a vocational classification is available for your candidate.

Once the Classification Committee approves the classification, invite your new member candidate to a weekly meeting. If the candidate expresses interest in joining our club, then ask Membership Chair Charles to send the candidate an invitation to apply online. Once the new member candidate completes the application, Board members review the application. Then, new member candidates are presented for formal approval at the monthly Board meeting. Once approved by the Board, new member candidates are announced in Throbs. Unless there is objection by any existing member, the new member is scheduled for orientation and formal induction. All members of our club need to think about who would make good Rotarians!
