Macon Action Plan

Church on July 22. The speaker will be our own Alex Morrison, who is Executive Director of the Macon-Bibb Urban Development Authority. He'll get us up to date on the Macon Action Plan, which is a comprehensive, community-driven, plan that envisions the future of Macon's Urban Core.

The original Macon Action Plan was approved in October of 2015. Within five years of completing the first plan, Downtown had attracted \$5 million in



foundation grants and over \$400 million of additional public and private investment. MAP's partners and the Downtown community had implemented 80 percent of the strategies from the original plan! It was time for a refresh...

MEETING July 15, 2024

Attendance: 48.5% - 59 in person, plus 8 guests

Our meeting was held at Fall Line Station, adjacent to Fall Line Brewing Company, and was a refreshing change to our normal routine. Attendance was pretty good for an off-site meeting with no Zoom option.

President Danny Gibson rang the bell and welcomed the members and guests. He called on Jeffery Monroe to do double duty by leading the song and pledge as well as offering the prayer. Jeffrey led us in *God Bless America*, and is one of the very few members (the only one?) who could have done that *a cappela* (and in tune!) Lacking a flag, we pledged allegiance in the general direction of the courthouse.

Danny thanked member Kaitlynn Kressin for opening up her wonderful facility for us while the church is holding Vacation Bible School. We'll be back at the church for the July 22 meeting. He then welcomed our many guests, which included several young people learning the insurance and legal professions.

Danny announced that Julie Petherbridge celebrated her birthday July 11 and Sam Robinson's will be the 21st. Past President Katherine Dennis marks 24 years of service to our club.

It was then time for CART brags. Steve Allen encouraged members to put money in the blue buckets even if they didn't have a brag, to make up for not having a raffle today.







President Danny reminded us that we will be back at First Presbyterian Church for our meeting next week. He will be out of town, so Susan Welsh will lead the meeting. He also offered a "today in

history" lesson from 1927. In that year, 21-year-old golfer Bobby Jones won the British Open Men's Golf title at St. Andrews, Scotland.

It was then time for the program. Jessica Walden introduced Gary Bechtel, Chairman of the Macon Water Authority, who is already well-known in Macon and is a former member of our club. She thanked him for his many years of service which included leadership positions on the Bibb County Board of Education, Planning and Zoning, the Professional Standards Commission, and many others. His business background is in banking and finance. Jessica noted that he met his wife at a Chamber of Commerce Business After Hours event.

Gary began by complimenting our club for being a staple in the community for over 100 years and thanked us for the honor of being with us today.

He was elected Chairman of MWA in 2022, following in the footsteps of many who served the community and built the institution into what it is today. Notably, Frank Amerson, whose name graces the water treatment plant in Jones county that he was so instrumental in establishing on the heels of the 1994 flood. Last month marked 30 years since Tropical Storm Alberto struck the Gulf coast and caused major flooding that changed this community forever. It was leaders like Frank Amerson who turned a disaster into an opportunity and as a result we now have a state-of-the-art water treatment plant which appropriately bears his name and a 5.8-billion-gallon reservoir that protects the citizens and businesses of Macon-Bibb and surrounding counties from other disasters or events that may impact us in the future.

Gary further explained how MWA works and then commended the vision of Macon leaders who, in the



1970's, created the Macon Water Authority to be separate from government. It was formerly the Macon Water Commission, and Gary said if you look at some of the problems that have occurred in other large cities in the last few years we can appreciate this vision. By establishing the Authority, they took it out of a political environment that did not always prioritize the health of the system. This is evident with the problems in Jackson, Mississippi, Flint, Michigan and more recently Atlanta.

The Macon Water Authority has one goal, to provide water and sewer services and grow and maintain the system for that purpose. "Our service is not restricted by political subdivisions and as a result, we sell water to Monroe County which is distributed and billed by the Monroe County commission. We provide sewer service to the City of Byron in Peach County and of course provide limited water and sewer service in parts of Jones County."

Gary offered a wide-ranging overview of the water and sewer system replete with statistics. The Amerson Water Treatment plant has a maximum treatment rate of 60 million gallons per day with the capability of producing 90 MGD. During non-summer months use averages 25-28 MGD with an increase up to 33-35MGD during the summer, so we have the capacity to sell a lot of water.

The river reservoir has a capacity of 5.8 billion gallons of water. The reservoir can hold a 90- to 120-day water supply. The entire Amerson Plant, including the Javors Lucas reservoir is over 3,000 acres.

"But when you sell water you have to have sewer capacity to treat the wastewater. We have two wastewater plants, Lower Poplar Water Reclamation Facility and Rocky Creek Water Reclamation Facility. Lower Poplar was built in 1959 as a 12 MGD facility for the princely sum of \$1.72 million. With further improvement and renovations totaling \$31 million it is now capable of processing 20 MGD of wastewater. Lower Poplar averages 13.5 MGD. We are now in the process of upgrading additional systems at Lower Poplar. We are investing to ensure the redundancy we need to protect the plant in the event of failure of the primary pumps as well as allowing us opportunities for the preventive maintenance that is needed on these large pumps. That work has been designed and planned and should start in earnest at the end of 2024.

"Rocky Creek Water Reclamation Facility was completed in 1974 as a 14 MGD plant at a cost of \$3.3 million. The original facility has undergone a series of expansions and upgrades since 1974 that has increased the treatment capacity to 28 MGD. Approximately 40% of the capacity is used by Graphic Packaging which averages between 9 and 11 MGD and is MWA's largest customer. Additionally, Irving Paper is a heavy user of Rocky Creek. For these reasons, we are in the process of designing and funding an expansion of Rocky Creek.

"We currently have 54,256 customer connections for water service. We have six pump stations, 1400 miles of pipe ranging from 72" to 6', we have over 19,301 valves to control pressure, 20 water tanks, 10 elevated and 10 ground tanks. We have over 8,208 fire hydrants and seven different pressure zones that are controlled and managed at Amerson Water Plant. On the sewer side, we have 43,545 sewer connections, 55 pump stations, 8 major pump(lift) stations, over 1,020 miles of pipe ranging from 54' to 8' pipe as well as 20,000 manholes.



"It is a large system and MWA currently has over 260 employees working on our system."

This large system does have its problems, chiefly aging infrastructure. In the last five years MWA has replaced all the residential meters with ones that can be read remotely, and plans are in place to replace all the commercial meters.

MWA is also in charge of the levee and took over stormwater responsibilities in 2021. It's important to keep catch basins free of litter but unfortunately many see them as a place to throw garbage. Since 2021 the Authority has removed almost 12,000 tons of debris.

In short, Gary Bechtel and the Authority are tasked with an enormous responsibility that they seem to be managing admirably.

There was no CART raffle, so the \$578 jackpot will be carried over and increased at our next meeting. As always, the meeting concluded with recitation of the Four Way test.
