Expertise

As a Certified Florida Appraiser and Assessment Administration Specialist, Ms. Jacks has the highest professional designation in Florida and one of the highest international designations for someone who holds the office of Property Appraiser.

Excellence

With a strong focus on continuous education, Ms. Jacks has staffed her office with professional and technical experts with the highest industry credentials, making the office a global model of top-tier appraisal and assessment practices. She equips her staff with the knowledge they need to exceed their customers' expectations. That level of expertise, along with the fact that anyone can reach one of those experts with just one phone call, gives Palm Beach County residents, businesses and other professionals confidence that their Property Appraiser is knowledgeable, trustworthy and always available to listen and help. In 2021, the office earned the prestigious Certificate of Excellence in Assessment Administration (CEAA) from the International Association of Assessing Officers (IAAO), a 7,000-member worldwide organization of professional assessing and appraising officials. The CEAA is the highest honor for a property appraiser's office.

Innovation

For more than 30 years, Ms. Jacks has been a champion for modernizing practices and enhancing transparency through the use of innovative technologies that make the appraisal process less subjective, and therefore, fairer and more equitable. Her focus on efficiency and accountability enables her to invest in these technologies. For example, she leveraged savings from a 15 percent staff reduction to invest in new technologies.

Among Ms. Jacks' most notable accomplishments is the creation of the award-winning Property Appraiser's Public Access (PAPA) website, the go-to tool for business, industry and government to access property data. It's free and it's available 24/7, as is PAPA Mobile, the browser-based tool for mobile devices. Ms. Jacks is focused every day on making the Property Appraiser's office better than it was the day before. She will keep up her tradition of constantly moving the office forward with emphasis on continuous improvement, streamlining operations, seeking new ways to make it easier for her customers to interact with her office, developing partnerships with municipalities and other government entities and empowering her customers through education.

Leadership

Unlike many other elected positions, the Property Appraiser job must be filled by a proven industry leader. Ms. Jacks' expertise in property appraisal, assessment administration, tax law and government jurisdiction operations has earned her regional, national and worldwide recognition in her field. She served as president of IAAO, a 7,000-member worldwide organization of professional assessing and appraising officials in 2018, and president of the Florida Association of Property Appraisers in 2021. She also is a past president of the Florida Chapter of IAAO.

Community Involvement

A long-time West Palm Beach resident, Ms. Jacks is also known for a lifetime of leadership in her community. She is a board member of the Friends of the Mounts Botanical Garden and an active alumnus and former board member of Leadership Palm Beach County. She has served as president of Executive Women of the Palm Beaches and president of the Friends of the Mandel Public Library. She is also a former member of the City of West Palm Beach Zoning Board of Appeals.

Ms. Jacks earned her bachelor's degree in political science from the University of Florida.

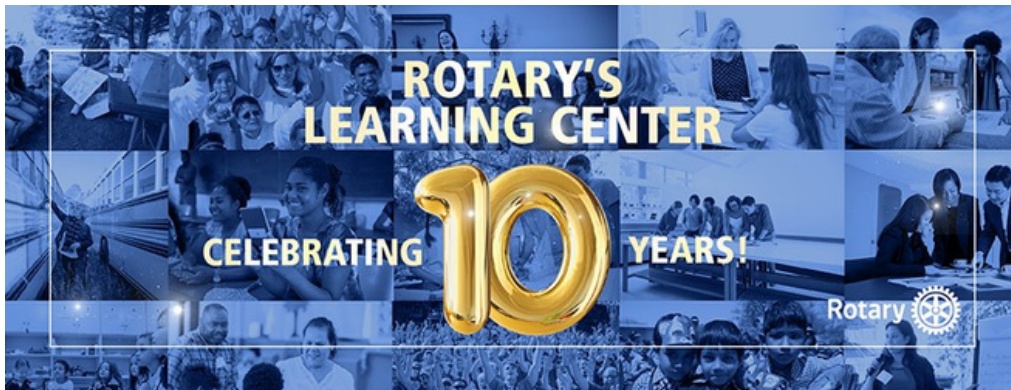
The Rotary Club of Delray Beach has been committed to serving the Delray Beach community since 1948!

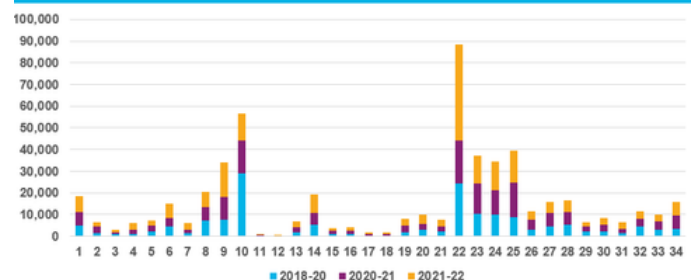

Rotary Donor Recognition

The **Paul Harris Fellow** recognition acknowledges individuals who contribute, or who have contributions made in their name, of \$1,000 to The Rotary Foundation.

Rotary established the recognition in 1957 to encourage and show appreciation for substantial contributions to what was then the Foundation's only program, Rotary Foundation Fellowships for Advanced Study, the precursor to Ambassadorial Scholarships.

The first Paul Harris Fellows included past RI Director Allison G. Brush, who served during the 1937-38 Rotary year, and longtime RI Treasurer Rufus F. Chapin, both for donations made in 1946. Mrs. Adan Vargas was the first woman to receive the recognition, for a gift made in 1953. Mrs. Harry L. Jones was the second, and one of only five people recognized for contributions actually made in that inaugural year.

Early Paul Harris Fellows received a certificate of recognition. In 1969, the Foundation unveiled the first Paul Harris Fellow medallion at the Rotary Convention in Honolulu, Hawaii, USA. Japanese metal artist Fiju Tsuda created the piece under the direction of former Foundation Trustee Kyozo Yuasa. Today, Paul Harris Fellows receive a certificate and pin. They are also eligible to buy a Paul Harris Fellow medallion.

Rotarians have a tradition of supporting the Foundation by honoring others. Ida LeTulle Taylor became a Paul Harris Fellow in 1978 when her husband, Vann Taylor, who was serving as a district governor, made a donation in her name in honor of their 34th wedding anniversary. The gift also made her the 25,000th Paul Harris Fellow.

Rotary Donor Recognition

Rotary Foundation Sustaining Member

When you give \$100 or more per year to the Annual Fund.

Benefactor

When you include the Endowment Fund as a beneficiary of \$1,000 or more in your estate plans or when you donate \$1,000 or more to the fund outright. Benefactors receive a certificate and insignia to wear with a Rotary or Paul Harris Fellow pin.

Paul Harris Fellow

When you give \$1,000 or more to the Annual Fund, PolioPlus, or an approved Foundation grant. To recognize someone else as a Paul Harris Fellow, you can give that amount in their name. Learn more about Paul Harris Fellow recognition.

Multiple Paul Harris Fellow

When you give additional gifts of \$1,000 or more to the Annual Fund, PolioPlus, or an approved Foundation grant.

Paul Harris Society member

When you elect to contribute \$1,000 or more annually to the Annual Fund, PolioPlus, or an approved Foundation grant. Learn more about the Paul Harris Society.

Major Donor

When your cumulative donations reach \$10,000. Major Donors can choose to receive a crystal recognition piece and a Major Donor lapel pin or pendant. NOTE: Name recognition is not automatic and needs to be reported to RI staff. Recognition items commemorate giving at these levels:

- Level 1: \$10,000 to \$24,999
- Level 2: \$25,000 to \$49,999
- Level 3: \$50,000 to \$99,999
- Level 4: \$100,000 to \$249,999

When you make a commitment for future gifts of \$10,000 or more to The Rotary Foundation, you'll be invited to join the Bequest Society.

\$10,000: Bequest Society pin and an exclusive art piece suitable for framing

\$25,000: Rotary's Promise crystal and named endowed fund, plus all of the above

\$50,000: Separate named endowed funds directed to two areas of focus or districts, plus all of the above

\$100,000: Customized Rotary's Promise crystal, plus all of the above

\$250,000: Posthumous induction into the Arch Klumph Society, plus all of the above

\$500,000: Special seating and registration benefits at the Rotary International Convention, plus all of the above

When your cumulative donations reach \$250,000. Recognition includes an induction ceremony and your picture and biography in the Arch Klumph Society interactive gallery at the Rotary International headquarters in Evanston, Illinois, USA. You also receive invitations to society events, along with membership pins and crystals that commemorate giving at the following levels. Learn more about the Arch Klumph Society.

Trustees Circle: \$250,000 to \$499,999

Chair's Circle: \$500,000 to \$999,999

Foundation Circle: \$1,000,000 to \$2,499,999

Platinum Trustees Circle: \$2,500,000 to \$4,999,999

Platinum Chair's Circle: \$5,000,000 to \$9,999,999

Platinum Foundation Circle: \$10,000,000 and above

When you promise a gift of \$1 million or more to the Endowment, you'll be listed in Rotary's annual report and invited to exclusive Rotary International and Foundation events. Legacy Society members also receive special recognition items and all the benefits provided to Bequest Society members.
