# Ak' Tenamit

## District Trip in February 2023

We are excited to go to Ak'Tenamit in February and hope you can join us contributing to the incredible work of the school!!

Here is the plan for the **February District trip to the Peten' Campus of Ak'Tenamit**: We have travelers flying to Guatemala from MCO and MIA on the 18th, then connecting as a group for the afternoon to Flores, which is close to the new Ak'Tenamit campus, and the Tikal preserve.

As you plan air travel, we need to synchronize the flights from GUA to Flores on the national airline TAG, [tag.com.gt](http://tag.com.gt), as the planes are limited, and the 3 hours needed to land at GUA, pick up checked bags, clear customs, and get to the TAG gate.

TAG' pricing has 3 tiers and you should choose the top, more expensive, tier as it has fewer baggage restrictions-many travelers on this flight are day trippers to Tikal with minimal baggage. The TAG flights are:

For GUA to Flores, Flt 5U120 with a departure on the 18th at 6:40 pm, arriving at 7:35 pm

For Flores to GUA, Flt 5U141 with a departure on the 25th at 10:45 am, arriving at 11:40 am

Some are considering staying longer and will make other arrangements for their departure from Guatemala; it is important for us to arrive together, and Steve is arranging for the ground transportation of the group during our week.

Steve will arrange for our hotels, and we will individually pay for our lodging and meals. The hotel will be around \$75 a night for a double occupancy room. The cost of meals should run around \$40 a day.

Workdays will be Sunday-Wednesday/Thursday. The itinerary for lodging is:

Saturday - arrive GUA fly to Flores stay at Maya Internacional Hotel

Sunday through Thursday - work stay at Hacienda San Vicente

Friday - Tikal and Flores Maya Internacional Hotel dinner with Rotary Club

Saturday - fly to GUA and USA

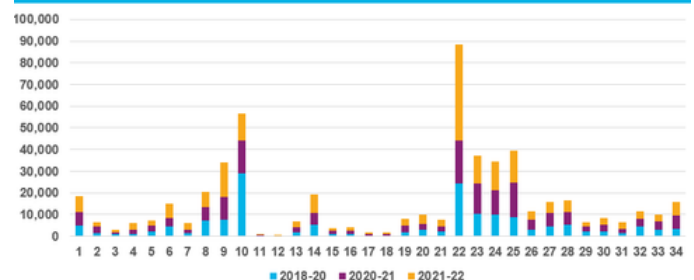

### COURSE COMPLETIONS BY ZONE







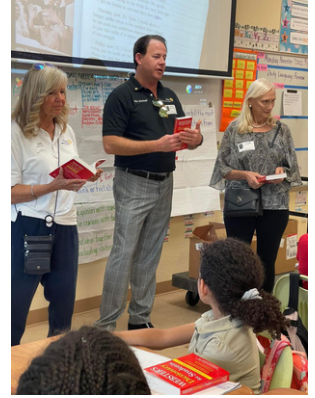

## Rotary Donor Recognition

The **Paul Harris Fellow** recognition acknowledges individuals who contribute, or who have contributions made in their name, of \$1,000 to The Rotary Foundation.

Rotary established the recognition in 1957 to encourage and show appreciation for substantial contributions to what was then the Foundation's only program, Rotary Foundation Fellowships for Advanced Study, the precursor to Ambassadorial Scholarships.

The first Paul Harris Fellows included past RI Director Allison G. Brush, who served during the 1937-38 Rotary year, and longtime RI Treasurer Rufus F. Chapin, both for donations made in 1946. Mrs. Adan Vargas was the first woman to receive the recognition, for a gift made in 1953. Mrs. Harry L. Jones was the second, and one of only five people recognized for contributions actually made in that inaugural year.

Early Paul Harris Fellows received a certificate of recognition. In 1969, the Foundation unveiled the first Paul Harris Fellow medallion at the Rotary Convention in Honolulu, Hawaii, USA. Japanese metal artist Fiju Tsuda created the piece under the direction of former Foundation Trustee Kyozo Yuasa. Today, Paul Harris Fellows receive a certificate and pin. They are also eligible to buy a Paul Harris Fellow medallion.

Rotarians have a tradition of supporting the Foundation by honoring others. Ida LeTulle Taylor became a Paul Harris Fellow in 1978 when her husband, Vann Taylor, who was serving as a district governor, made a donation in her name in honor of their 34th wedding anniversary. The gift also made her the 25,000th Paul Harris Fellow.

# Rotary Donor Recognition

## Rotary Foundation Sustaining Member

When you give \$100 or more per year to the Annual Fund.

## Benefactor

When you include the Endowment Fund as a beneficiary of \$1,000 or more in your estate plans or when you donate \$1,000 or more to the fund outright. Benefactors receive a certificate and insignia to wear with a Rotary or Paul Harris Fellow pin.

## Paul Harris Fellow

When you give \$1,000 or more to the Annual Fund, PolioPlus, or an approved Foundation grant. To recognize someone else as a Paul Harris Fellow, you can give that amount in their name. Learn more about Paul Harris Fellow recognition.

## Multiple Paul Harris Fellow

When you give additional gifts of \$1,000 or more to the Annual Fund, PolioPlus, or an approved Foundation grant.

## Paul Harris Society member

When you elect to contribute \$1,000 or more annually to the Annual Fund, PolioPlus, or an approved Foundation grant. Learn more about the Paul Harris Society.

## Major Donor

When your cumulative donations reach \$10,000. Major Donors can choose to receive a crystal recognition piece and a Major Donor lapel pin or pendant. NOTE: Name recognition is not automatic and needs to be reported to RI staff. Recognition items commemorate giving at these levels:

- Level 1: \$10,000 to \$24,999
- Level 2: \$25,000 to \$49,999
- Level 3: \$50,000 to \$99,999
- Level 4: \$100,000 to \$249,999

When your cumulative donations reach \$250,000. Recognition includes an induction ceremony and your picture and biography in the Arch Klumph Society interactive gallery at the Rotary International headquarters in Evanston, Illinois, USA. Trustees Circle: \$250,000 to \$499,999

Chair's Circle: \$500,000 to \$999,999

Foundation Circle: \$1,000,000 to \$2,499,999

Platinum Trustees Circle: \$2,500,000 to \$4,999,999

Platinum Chair's Circle: \$5,000,000 to \$9,999,999

Platinum Foundation Circle: \$10,000,000 and above

When you promise a gift of \$1 million or more to the Endowment, you'll be listed in Rotary's annual report and invited to exclusive Rotary International and Foundation events. Legacy Society members also receive special recognition items and all the benefits provided to Bequest Society members.
