Hurricane Ian Relief – Work Party Volunteers

Dear Area 6 Rotarians:

District 6950 had a fantastic response to our call for donation of relief items, and now we're entering the next phase of assistance to Hurricane Ian victims. We will be organizing work parties and volunteers to go to the affected areas over the next several weekends.

We need to assemble a roster of volunteers, their availability, their skills or work preferences, and any special equipment they can provide for their own use while on the worksites. We caution all volunteers – all work will be done in a disaster area, and it may hazardous as well as strenuous. You may be exposed to chemicals, biohazards, and debris that could cause serious illness or injury. Volunteers must understand that participation in this relief effort is at their own risk, and those with health issues or physical limitations to take these factors into account when volunteering.

Here is a list of some of the types of assistance needed currently:

- 1 Tree work / Chainsaw work this will largely involve cutting up downed trees and limbs for removal. This is heavy labor, and potentially dangerous. Volunteers must be experienced in chainsaw operation and should be able to provide their own chainsaw and equipment, including gloves, ear and eye protection. This is not work for the inexperienced homeowner who just happens to have a chainsaw.
- 2 Aluminum pickup and collection for removal this will involve cleanup of destroyed / damages carports, gutters, siding and other building materials and moving the debris to a curbside collection

- location. This can involve heavy lifting, and protective gloves and clothing, including sturdy shoes or work boots, is necessary to avoid cuts and scrapes.
- 3 Roof Tarping this will involve securing tarps, visqueen or similar materials to damaged roofs for protection against further water intrusion. It will require climbing a ladder and working on sloped and potentially damaged or weakened roof systems.
- Mucking and Gutting this involves removing mud, muck, silt and sand deposited by floodwaters ("mucking") and damaged building materials, such as drywall, flooring, paneling, insulation
- and cabinets ("gutting") from structures to prepare them for the repair and rebuilding process. It also includes removing damaged appliances, furniture, and personal items from the home, and securing undamaged items for retrieval by the homeowner. It is heavy labor, and volunteers need sturdy shoes / boots and gloves.
- Food and Water Distribution a crucial but slightly less physical assignment that may involve setting up and supplying food and water distribution lines in shelters or delivering food and water to volunteers and residents in the field.

We intend for volunteers to be assigned where they can best be used, so there are no guaranteed assignments, but these are the types of activities needed now.

For now, we are requesting volunteers who are available on any of the following weekends:

Saturday, October 22 and Sunday, October 23 Saturday, October 29 and Sunday, October 30 Saturday, November 12 and Sunday, November 13

- 7 If you have a larger vehicle, and are willing to transport other volunteers from your area to/from the Fort Myers area, please include that information as well.

It is important to provide all information requested above, so we can build a spreadsheet of volunteers and make sure we have adequate coverage for the listed dates.

We will be in touch once we have further information, including options for overnight accommodations. Thank you.


